**ROAD TRAFFIC REGULATION ACT 1984**

**THE COUNTY OF WILTSHIRE (VARIOUS ROADS, SALISBURY)**  
**(PROHIBITION AND RESTRICTION OF WAITING, LOADING AND**  
**UNLOADING) ORDER 2000 (AMENDMENT NO 2) ORDER 2000**

The Council of the County of Wiltshire in exercise of its powers under Sections 1(1), 2(1) to (3), 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

1. The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 as amended (hereinafter referred to as 'the Order of 2000') shall be further amended by: -

- (a) The insertion after Article 10 of the Order of 2000 of the following new Articles: -

- 10A. Save as provided in Articles 18, 19 and 20 of this Order no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden cause or permit any vehicle to wait in the lengths of road specified in Schedule 18 to this Order during the following periods: -

Mondays to Fridays between 8.00 am and 10.00 am and Saturdays between 8.00 am and 12 noon.

- (b) The insertion after Article 17 of the Order of 2000 of the following new Article: -

- 17A. Save as provided in Articles 18 and 19 of this Order no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden cause or permit any vehicle to load and unload in the lengths of road specified in Schedule 19 to this Order during the following periods: -

Mondays to Fridays between 8.00 am and 10.00 am and Saturdays between 8.00 am and 12 noon.

- (c) The insertion after Article 18.(b)(iii), the following as 18.(b)(iii): -
- any of the lengths of road referred to in Schedule 19 to this Order between the hours of 8.00 am and 10.00 am on Mondays to Fridays and between 8.00 am and 12 noon on Saturdays.
- (d) Where Article 17 is mentioned in Article 18, it be amended to read 17A.
- (e) The deletion of Article 22 from the Order of 2000.
2. The deletion from Schedule 2 of the Order of 2000 of the lengths of road as specified in Schedule 1 to this Order.
  3. The deletion from Schedule 10 of the Order of 2000 of the length of road as specified in Schedule 2 to this Order.
  4. The addition to Schedule 2 of the Order of 2000 of the lengths of road as specified in Schedule 3 to this Order.
  5. The addition to Schedule 15 of the Order of 2000 of the length of road as specified in Schedule 4 to this Order.
  6. The addition as Schedule 18 of the Order of 2000 of the lengths of road as specified in Schedule 5 to this Order.
  7. The addition as Schedule 19 of the Order of 2000 of the lengths of road as specified in Schedule 6 to this Order.
  8. This Order shall come into operation on 27 November 2000 and shall be cited as The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting, Loading and Unloading) Order 2000 (Amendment No 2) Order 2000.

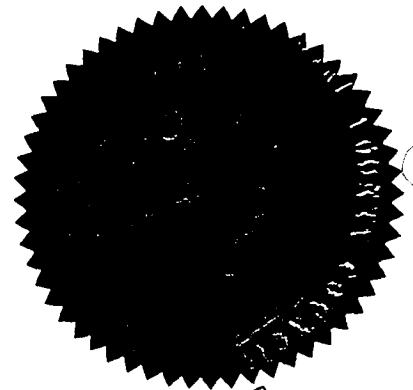


