ROAD TRAFFIC REGULATION ACT 1984

THE COUNTY OF WILTSHIRE (VARIOUS ROADS, SALISBURY)
(PROHIBITION AND RESTRICTION OF WAITING
LOADING AND UNLOADING) ORDER 2000
(AMENDMENT NO.5) ORDER 2001

The Council of the County of Wiltshire in exercise of its powers under Sections 1(1), 2(1) to (3), 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

1. The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (hereinafter referred to as "the Order of 2000) shall be further amended by:-
 - (a) The deletion from Schedule 2 of the Order of 2000 of the lengths of road specified in Schedule 1 to this Order;
 - (b) The deletion from Schedule 3 of the Order of 2000 of the lengths of road specified in Schedule 2 to this Order;
 - (c) The deletion from Schedule 4 of the Order of 2000 of the lengths of road specified in Schedule 3 to this Order;
 - (d) The deletion from Schedule 10 of the Order of 2000 of the length of road specified in Schedule 4 to this Order;
 - (e) The addition to Schedule 2 of the Order of 2000 of the length of road specified in Schedule 5 to this Order.

2. This Order will come into operation on 19 November 2001 and may be cited as The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (Amendment No.5) Order 2001.

SCHEDULE 1

Deletions from Schedule 2 of the Order of 2000 No Waiting at Any Time

<u>Road</u>	<u>Side</u>	<u>Description</u>
Blackfriars Way	Both Sides	from its junction with Friary Lane to a point 17 metres east of that junction
Blackfriars Way	North Side	from a point 14 metres east of its junction with Whitefriars Road to its junction with Friar's Orchard
Carmelite Way	South Side	from a point opposite the centre of Friary Lane to a point 40 metres east of that point including the rear access to St. Osmunds School
Eyres Way	East Side	from its northern end to a point 8 metres east of the centreline of the access into Tintern Court
Eyres Way	West and North Side	from its northern end, including the turning head for a distance of 16 metres southwards
	West and South Side	from a point in line with the southern boundary of number 5 Eyres Way to a point 8 metres east of the centreline of the access into Tintern Court
Eyres Way	North Side	from its junction with Friars Orchard to a point 8 metres west of the centreline of the access into Tintern Court
Friary Lane	East Side	from its junction with St. Ann Street to a point 78 metres south of that junction
Friary Lane	West Side	from its junction with St. Ann Street to a point 101 metres south of that junction

SCHEDULE 2

Deletions from Schedule 3 of the Order of 2000 **No Waiting Mon-Sat 8am-7pm**

<u>Road</u>	<u>Side</u>	<u>Description</u>
Friary Lane	Both Sides	from a point 101 metres south of its junction with St. Ann Street to its junction with Carmelite Way
The Friary	All Sides	the complete length

SCHEDULE 3

Deletions from Schedule 4 of the Order of 2000 **No Waiting Mon-Sat 9am-6pm**

<u>Road</u>	<u>Side</u>	<u>Description</u>
Carmelite Way	North Side	from its junction with Exeter Street to its junction with Friary Lane
Carmelite Way	South Side	from its junction with Exeter Street to a point 10 metres east of that junction

SCHEDULE 4

Deletion from Schedule 10 of the Order of 2000 **No Waiting 8am-7pm**

<u>Road</u>	<u>Side</u>	<u>Description</u>
St. Ann Street	South Side	From its junction with Exeter Street to its junction with Brown Street

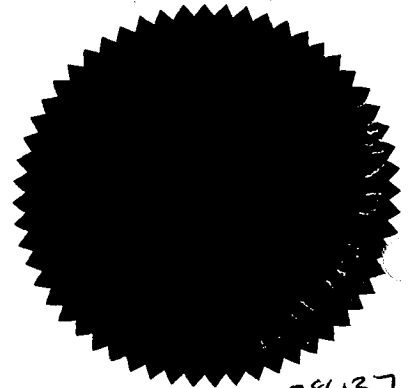
