ROAD TRAFFIC REGULATION ACT 1984 ROAD TRAFFIC ACT 1991

THE COUNTY OF WILTSHIRE (VARIOUS ORDERS) (IN THE DISTRICT OF SALISBURY) (DECRIMINALISED PARKING) (AMENDMENT) ORDER 2001

The Council of the County of Wiltshire in exercise of its powers under sections 1, 2, 4, 32, 35, 45, 46, 46A, 49, 51, 53, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended, in exercise of its powers under the Road Traffic Act 1991, as amended (whether generally or in relation to the Council's area or part thereof) (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- 1. Where in any Orders specified in Schedules 1 and 2 to this Order or any subsequent Orders which have the effect of amending the aforementioned Orders, reference is made in any of the said Orders in the District of Salisbury to "Traffic Warden or Car Parking Inspector" the words "Parking Attendant in uniform" shall be included.
- 2. In the Orders specified in Schedules 1 and 2 to this Order, the following Article shall be inserted:-
 - "Nothing in the provisions of this Order shall prevent any person from causing any vehicle to wait in any of the lengths of road subject to waiting restrictions provided permission has been obtained from Salisbury District Council by means of a formal document to be displayed in the front or nearside of the vehicle which includes information which enables the driver to be contacted in an emergency and providing that an obstruction is not caused by so doing and that the vehicle is moved if the driver is requested to do so by a police officer or Parking Attendant in uniform."
- 3. In the Orders specified in Schedule 2 to this Order, the definition of "Permit" shall be deleted and the following definition shall be inserted:
 - "Permit" means a permit issued by Salisbury District Council to either a Resident, Business or Visitor"

4. In the Orders specified in Schedule 2 to this Order the Article headed "Visitor's Permit" shall be deleted and the following Article shall be inserted:

"Visitors' Permits

Any resident whose usual residence is within a street specified in a schedule to this Order as qualifying for a Residents' Permit may apply to Salisbury District Council for Visitors' Permits, the display of which in the front or nearside of a vehicle will entitle the driver to the same privileges of parking for that day as if displaying a valid Residents' Permit."

5. In the Orders specified in Schedule 2 of this Order under the heading "Restriction of Waiting of Vehicles in Parking Places" the following Article shall be inserted:-

"Nothing in the provisions of this Order shall prevent any person from causing or permitting any vehicle to wait in a parking place for longer than two hours if the vehicle is displaying at its front or nearside:-

- (a) a formal document issued by Salisbury District Council
- (b) a British Medical Association badge or other evidence of a medical visit by the local Health Authority personnel, approved by the Salisbury District Council and the visit is for treatment of a patient living nearby."
- 6. (a) In the Orders specified in Schedule 1 to this Order the following Article shall be inserted; and
 - (b) Where reference is made in the Orders specified in Schedule 2 to this Order under the heading "Amount of Charge at Parking Places" this Article shall be deleted and the following Article shall be inserted:

"Amount of Charge At Parking Places

Where a vehicle has been left in contravention of the restrictions imposed by this Order, a Penalty Charge shall be incurred, the amount of which will be set by Wiltshire County Council under the provisions of the Act of 1991 relating to special parking areas and permitted parking areas.

Where a Penalty Charge is payable, a Penalty Charge Notice shall be issued by a Parking Attendant in accordance with the requirements of Schedule 3 of the Act of 1991."

7. (a) In the Orders specified in Schedule 1 to this Order the following Article shall be inserted; and

(b) Where in the Orders specified in Schedule 2 to this Order, an Article refers to "Manner of Payment of Parking Charges" the Article shall be deleted and replaced with the following Article:

"Manner of Payment of Penalty Charge Notice

The Penalty Charge Notice shall be paid within 28 days payable to Salisbury District Council under the terms referred to in the said Notice."

8. This Order shall come into operation on 1 April 2001 and may be cited as The County of Wiltshire (Various Orders) (In the District of Salisbury) (Decriminalised Parking) (Amendment) Order 2001.
