WILTSHIRE COUNTY COUNCIL (SALISBURY) (ST. EDMUND'S AREA)
(RESIDENTS' PARKING PLACES) ORDER 1989 (AMENDMENT NO.6)
ORDER 2001

The Wiltshire County Council in exercise of its powers under Sections 45, 46, 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

1. The Wiltshire County Council (Salisbury) (St. Edmund's Area) (Residents' Parking Places) Order 1989 (hereinafter referred to as "the Order of 1989" shall be further amended as follows:
 - (a) by the deletion from Schedule 1 of the Order of 1989 of the lengths of road specified in Schedule 1 to this Order;
 - (b) by the addition to Schedule 1 of the Order of 1989 of the lengths of road specified in Schedule 2 to this Order;

This Order will come into operation as from 23 March 2001 and may be cited as the Wiltshire County Council (Salisbury) (St. Edmund's Area) (Residents' Parking Places) Order 1989 (Amendment No.6) Order 2001.

Deletions from Schedule 1 of the Order of 1989

All that part of the north side of BELLE VUE ROAD (SOUTHERN SECTION) which is bounded on the north side by so much of the edge of the carriageway as extends from a point 12 metres east of its junction with Albany Road to a point 28 metres east of that junction and which has a width throughout of between 1.7 and 2.5 metres.	
15.	All that part of the south side of BELLE VUE ROAD (SOUTHERN SECTION) which is bounded on the south side by so much of the edge of the carriageway as extends from a point 38 metres east of its junction with Endless Street to a point 15 metres west of its junction with Albany Road and which has a width throughout of between 1.7 and 2.5 metres.	
16.	All that part of the south side of BELLE VUE ROAD (SOUTHERN SECTION) which is bounded on the south side by so much of the edge of the carriageway as extends from a point 12 metres east of its junction with Albany Road to a point 5 metres west of its junction with School Lane and which has a width throughout of between 1.7 and 2.5 metres.

	South	From a point 1m east of a point in line with the western boundary of No.2 Belle Vue Road to a point 2m east of a point in line with the boundary between Nos. 10 and 12 Belle Vue Road

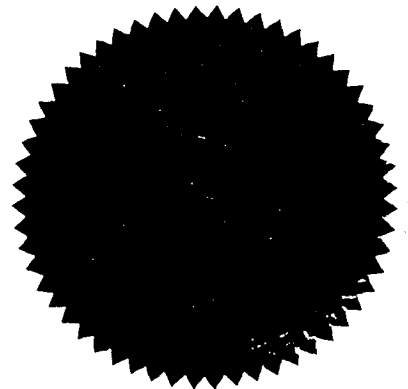
