ROAD TRAFFIC REGULATION ACT 1984

THE COUNTY OF WILTSHIRE (VARIOUS ROADS, SALISBURY) (PROHIBITION AND RESTRICTION OF WAITING LOADING AND UNLOADING) ORDER 2000 (AMENDMENT NO.3) ORDER 2001

The Council of the County of Wiltshire in exercise of its powers under Sections 1(1), 2(1) to (3), 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

- 1. The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (hereinafter referred to as "the Order of 2000" shall be further amended as follows:
 - (a) by the deletion from Schedule 2 of the Order of 2000 of the lengths of road specified in Schedule 1 to this Order;
 - (b) by the deletion from Schedule 5 of the Order of 2000 of the lengths of road specified in Schedule 2 to this Order;
 - (c) by the deletion from Schedule 12 of the Order of 2000 of the length of road specified in Schedule 3 to this Order;
 - (d) by the deletion from Schedule 15 of the Order of 2000 of the lengths of road specified in Schedule 4 to this Order;
 - (e) by the addition to Schedule 2 of the Order of 2000 of the lengths of road specified in Schedule 5 to this Order;
 - (f) by the addition to Schedule 5 of the Order of 2000 of the lengths of road specified in Schedule 6 to this Order;
 - (g) by the addition to Schedule 15 of the Order of 2000 of the lengths of road specified in Schedule 7 to this Order;
 - (h) where reference is made in Schedule 2 of the Order of 2000 to "Eyres Way East Side" these words shall be deleted and "Eyres Way East and South Side" shall be inserted;
 - (i) where reference is made in Schedule 5 of the Order of 2000 to "College Street South-west side from a point 14 metres north of its junction with the

access to the swimming pool to a point 1 metre south-east of a point in line with the boundary between numbers 90 and 92 College Street" after the words "swimming pool" the words "car park" shall be inserted".

This Order will come into operation as from 23 March 2001 and may be cited as The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (Amendment No.3) Order 2001.
