WILTSHIRE COUNTY COUNCIL (SALISBURY) (ST. EDMUND'S AREA)
(RESIDENTS' PARKING PLACES) ORDER 1989 (AMENDMENT NO.5)
ORDER 2001

Wiltshire County Council in exercise of its powers under Sections 45, 46, 49, 53 and Part IV of Section 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

1. The Wiltshire County Council (Salisbury) (St. Edmund's Area) (Residents' Parking Places) Order 1989 (hereinafter referred to as "the Order of 1989") shall be further amended by:
 - (a) the deletion from Schedule 1 of the Order of 1989 of the length of road specified in Schedule 1 to this Order;
 - (b) the addition from Schedule 1 of the Order of 1989 of the length of road specified in Schedule 2 to this Order.
2. This Order shall come into operation on 26 March 2001 and may be cited as The Wiltshire County Council (Salisbury) (St. Edmund's Area) (Residents' Parking Places) Order 1989 (Amendment No.5) Order 2001.

SCHEDULE 1

Deletion from Schedule 1 of the Order of 1989

Waiting Limited to 2 Hours, No Return Within 2 Hours,
Except Permit Holders, 9.00 am – 5.00 pm Monday to Saturday
(Excluding Bank Holidays)

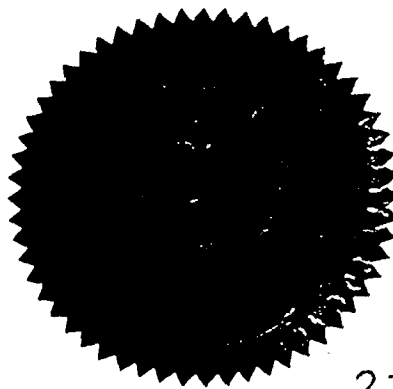
<u>Road</u>	<u>Side</u>	<u>Description</u>
Belle Vue Road	South	From a point 1 m. east of a point in line with the western boundary of No.2 Belle Vue Road to a point 2m. east of a point in line with the boundary between Nos.10 and 12 Belle Vue Road.

Addition to Schedule 1 of the Order of 1989
Waiting Limited to 2 Hours, No Return Within 2 Hours,
Except Permit Holders, 9.00 am – 5.00 pm Monday to Saturday
(Excluding Bank Holidays)

<u>Road</u>	<u>Side</u>	<u>Description</u>
Belle Vue Road	South	From a point 15 metres west of its junction with Albany Road to a point 41 metres west of that junction.
