ROAD TRAFFIC REGULATION ACT 1984

<u>THE COUNTY OF WILTSHIRE (VARIOUS ROADS, WILTON)</u> (PROHIBITION AND RESTRICTION OF WAITING) ORDER 1983 (AMENDMENT NO 1) ORDER 2001

The Council of the County of Wiltshire in exercise of its powers under Sections 1(1), 2(1) to (3), 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

- The County of Wiltshire (Various Roads, Wilton) (Prohibition and Restriction of Waiting) Order 1983 (hereinafter referred to as the 'Order of 1983') shall be amended by:
 - a) The deletion of Article 5 (ii) of the Order of 1983 and the insertion as Article 5(ii) of the following: -

(ii) if a period of less than two hours has elapsed since the termination during the said hours of the last period of waiting of the vehicle in the length of road.

- b) The deletion from Schedules 2 and 3 of the Order of 1983 of the lengths of road as specified in Schedules 1 and 2 to this Order.
- c) The deletion of Schedule 4 of the Order of 1983.

- d) The addition to Schedules 2, 3 and 5 of the Order of 1983 of the lengths of road as specified in Schedules 3, 4 and 5 to this Order.
- 2. This Order shall come into operation on 30 March 2001 and shall be cited as The County of Wiltshire (Various Roads, Wilton) (Prohibition and Restriction of Waiting) Order 1983 (Amendment No1) Order 2001.
