**WILTSHIRE COUNTY COUNCIL (SALISBURY – ZONE B)**  
**(WAITING RESTRICTIONS AND RESIDENTS’ PARKING BAY)**  
**ORDER 1997 (AMENDMENT NO.3) ORDER 2002**

The Council of the County of Wiltshire (“the Council”) in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 45, 46, 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) as amended, the Road Traffic Act 1991, as amended, (whether generally or in relation to the Council’s area, or part thereof) (hereinafter referred to as “the Act of 1991”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

1. Wiltshire County Council (Salisbury – Zone B) (Waiting Restrictions and Residents’ Parking Bay) Order 1997 (hereinafter referred to as “the Order of 1997) shall be amended as follows:

- (a) by the addition to the first paragraph of the Order of 1997 after “53” of “63A”
- (b) by the addition to Article 3(1) of the Order of 1997 of the following interpretation:

“formal document” means a document issued by Salisbury District Council to either a resident, business or visitor and includes a permit, waiver or other document issued by that Council to exempt a vehicle from waiting where a restriction applies or from a time limit under the terms and charges applicable at the time“.

- (c) by the removal from Article 3(1) of the Order of 1997 in the paragraph headed “Council” where reference is made to Section 113 of the Local Government Act of 1972 “Section 113” should be deleted and replaced by “Section 101”
- (d) by the addition to Article 3(1) of the Order of 1997 of the following interpretation:

““Parking Attendant” means a person employed by the Council for the control of the parking of vehicles in public parking places in Salisbury District in accordance with the regulations in force for those parking places”

- (e) by the deletion from Article 3(1) of the Order of 1997 of the interpretation commencing “permitted hours” and the replacement of the following interpretation:

“permitted hours” means the period between 8.00 am and 6.00 pm Monday to Saturday inclusive but excluding any such day that is Christmas Day or a Bank Holiday”

- (f) by the deletion from Article 9 of the Order of 1997 after the words “Schedule 11 to this Order” of the words “for a longer period than two hours, or if a period of less than four hours has elapsed since a previous period of waiting by the same vehicle in the same length of road”

- (g) by the deletion from Article 10 of the Order of 1997 of the word “permit” and the replacement of the words “formal document”

- (h) by the deletion from Article 10 of the Order of 1997 after the words ”provisions of this Order” of the words ”for a period longer than two hours”

- (i) by the deletion of the words “for longer than two hours” from the Article under the heading “Restriction of Waiting of Vehicles in Parking Places” and which reads:

“Nothing in the provisions of this Order shall prevent any person from causing or permitting any vehicle to wait in a parking place for longer than two hours if the vehicle is displaying at its front or nearside:-“

- (j) by the deletion from Schedule 11 of the Order of 1997 of the heading “Waiting Limited to 2 Hours No Return Within 4 Hours (Except Permit Holders) 9.00a.m. - 5.00p.m. Monday - Saturday” and the addition of the heading “On Street Parking (Permit Holders Only) Monday to Saturday 8.00 am to 6.00 pm”

- (k) by the deletion from Schedule 11 of the Order of 1997 of the lengths of road specified in Schedule 1 to this Order;

- (l) by the addition to Schedule 11 of the Order of 1997 of the lengths of road specified in Schedule 2 to this Order;

- (m) by the addition to Schedule 12 of the Order of 1997 of the lengths of road specified in Schedule 3 to this Order.

2. This Order shall come into operation on 7 May 2002 and may be cited as Wiltshire County Council (Salisbury – Zone B) (Waiting Restrictions and Residents’ Parking Bay) Order 1997 (Amendment No.3) Order 2002.

**SCHEDULE 1**

**Deletions from Schedule 11 of the Order of 1997**

**Waiting Limited to 2 Hours, No Return Within 4 hours (Except Permit Holders)**  
**9 a.m. – 5 p.m. Monday – Saturday**

<b><u>Road</u></b>	<b><u>Side</u></b>	<b><u>Description</u></b>
Cranebridge Road	South-West	From a point 16 metres south-east of its junction with Mill Road to a point 54 metres south-east of that junction.
Dews Road	West	From a point 12 metres south of its junction with South Western Road to a point 20 metres south of that junction.
West Street	North	From a point 10 metres east of its junction with Dews Road to a point 7 metres west of its junction with North Street.

**SCHEDULE 2**

**Addition to Schedule 11 of the Order of 1997**

**On Street Parking (Permit Holders Only)**  
**Monday to Saturday 8.00 am to 6.00 pm**

<b><u>Road</u></b>	<b><u>Side</u></b>	<b><u>Description</u></b>
West Street	North	From a point 10 metres east of its junction with Dews Road to a point 18 metres west of its junction with North Street.




