THE COUNTY OF WILTSHIRE (VARIOUS ROADS, SALISBURY)
(PROHIBITION AND RESTRICTION OF WAITING
LOADING AND UNLOADING) ORDER 2000
(AMENDMENT NO.7) ORDER 2002

The Council of the County of Wiltshire in exercise of its powers under Sections 1(1), 2(1) to (3), 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended, The Road Traffic Act 1991, as amended, (whether generally or in relation to the Council's area, or part thereof) (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

1. The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (hereinafter referred to as "the Order of 2000) shall be amended by:-

- (a) the addition to the first paragraph of the Order of 2000 after the figure "4" of "63A";
- (b) the deletion from Schedule 2 of the Order of 2000 of the lengths of road specified in Schedule 1 to this Order;
- (c) the deletion from Schedule 3 of the Order of 2000 of the lengths of road specified in Schedule 2 to this Order;
- (d) the deletion from Schedule 4 of the Order of 2000 of the lengths of road specified in Schedule 3 to this Order;
- (e) the deletion from Schedule 11 of the Order of 2000 of the lengths of road specified in Schedule 4 to this Order;
- (f) the insertion to Article 24 of the Order of 2000 of the following:

""formal document" means a document issued by Salisbury District Council to exempt a vehicle from waiting where a restriction applies or from a time limit";

2. This Order will come into operation on 7 May 2002 and may be cited as The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (Amendment No.7) Order 2002.

SCHEDULE 1

Deletion from Schedule 2 of the Order of 2000

No Waiting At Any Time

<u>ROAD</u>	<u>SIDE</u>	<u>DESCRIPTION</u>
Exeter Street	East	The complete length.
	West	From its junction with St. Ann Street to a point 50 metres south of the centreline of St. Anne's Gate.
	West	From a point 123 metres south of the centreline of St. Anne's Gate to a point 81 metres north of the centreline of Carmelite Way.
	West	From its junction with Newbridge Roundabout to a point 90 metres south of the centreline of Carmelite Way.
Scots Lane	North	From its junction with Endless Street to a point 7 metres west of that junction.

SCHEDULE 2

Deletion from Schedule 3 of the Order of 2000

No Waiting Mon-Sat 8am-7pm

<u>ROAD</u>	<u>SIDE</u>	<u>DESCRIPTION</u>
Exeter Street	West	From its junction with Churchill Way South to a point 11 metres north of a point opposite the centreline of Carmelite Way.
Scots Lane	North	From its junction with Castle Street to a point 52 metres east of that junction.
	North	From a point 7 metres west of its junction with Endless Street to a point 21 metres west of that junction.
Scots Lane	South	The complete length.

SCHEDULE 3

Deletion from Schedule 4 of the Order of 2000

No Waiting Mon-Sat 9am-6pm

<u>ROAD</u>	<u>SIDE</u>	<u>DESCRIPTION</u>
Exeter Street	West	From a point 90 metres south of the centreline of Carmelite Way to a point 15 metres north of that centreline.



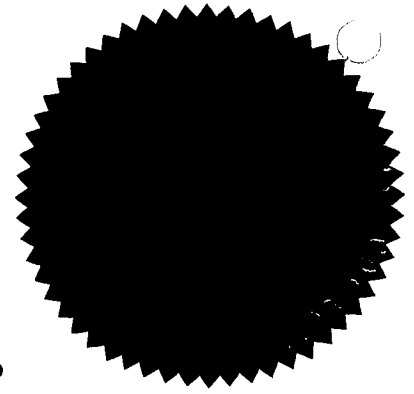
Deletion from Schedule 11 of the Order of 2000

Waiting Limited to 2 hours, Return Prohibited Within 2 Hours
Mon-Sat 9.30am – 4.00 pm

<u>ROAD</u>	<u>SIDE</u>	<u>DESCRIPTION</u>
Exeter Street	West	From a point 15 metres north of the centreline of Carmelite Way to a point 81 metres north of that centreline.
	West	From a point 50 metres south of the centreline of St. Anne's Gate to a point 123 metres south of that centreline.
Scots Lane	North	From a point 52 metres east of its junction with Castle Street to a point 21 metres west of its junction with Endless Street with vehicles parking in marked bays and onto the kerb.
