**THE COUNTY OF WILTSHIRE (VARIOUS ROADS, SALISBURY) (PROHIBITION AND RESTRICTION OF WAITING LOADING AND UNLOADING) ORDER 2000**  
**(AMENDMENT NO 6) ORDER 2002**

The Council of the County of Wiltshire in exercise of its powers under Sections 1(1), 2(1) to (3), 4, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and the Road Traffic Act 1991, as amended, (whether generally or in relation to the Council's area, or part thereof) (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

1. The City of New Sarum (Saxon Road) (Prohibition of Right Hand Turn) Order 1974 is hereby revoked.
2. The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 as amended (hereinafter referred to as "the Order of 2000") shall be further amended by: -
  - (a) The insertion after Article 10A of the Order of 2000 of the following new Article: -

10B Save as provided in Articles 18, 19 and 20 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Parking Attendant cause or permit any vehicle to wait between the hours of 8.00 am and 6.00 pm on any day in the length of road specified in Schedule 20 to this Order.
  - (b) Where reference is made to Article 10 in Article 20 of the Order of 2000, it be amended to read 10B;
  - (c) The deletion from Schedule 3 of the Order of 2000 of the lengths of road specified in Schedule 3 to this Order;
  - (d) The addition to Schedule 2 of the Order of 2000 of the lengths of road as specified in Schedule 1 to this Order;
  - (e) The addition as Schedule 20 of the Order of 2000 of the length of road as specified in Schedule 2 to this Order.
3. This Order shall come into operation on 25 February 2002 and shall be cited as The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (Amendment No 6) Order 2002.

## **SCHEDULE 1**

### **Additions to Schedule 2 of the Order of 2000** **No Waiting at Any Time**

<b><u>Road</u></b>	<b><u>Side</u></b>	<b><u>Description</u></b>
Harnham Road	south	from its junction with Saxon Road to a point 30 metres west of that junction
Montague Road	both	from its junction with Netherhampton Road to a point 15 metres south of that junction
Netherhampton Road	south	from a point 20 metres west of its junction with Montague Road to a point 20 metres east of that junction
Saxon Road	both	from its junction with Harnham Road to its junction with Parsonage Green

### **Addition as Schedule 20 of the Order of 2000** **No Waiting 8am-6pm on Any Day**


<b><u>Road</u></b>	<b><u>Side</u></b>	<b><u>Description</u></b>
Castle Street	west	from its junction with Wyndham Road to its junction with Churchill Way

### **Deletions from Schedule 3 of the Order of 2000** **No Waiting Mon-Sat 8am-7pm**

<b><u>Road</u></b>	<b><u>Side</u></b>	<b><u>Description</u></b>
Castle Street	west	from its junction with Wyndham Road to its junction with Churchill Way
Exeter Street	west	from its junction with Churchill Way South to a point 11 metres north of a point opposite the centreline of Carmelite Way
