ROAD TRAFFIC REGULATION ACT 1984 ROAD TRAFFIC ACT 1991

THE COUNTY OF WILTSHIRE (CENTRAL SALISBURY) (PROHIBITION AND RESTRICTION OF WAITING, LOADING AND UNLOADING) ORDER 2004

The Council of the County of Wiltshire in exercise of its powers under Sections 1(1), 2(1) to (3), 4, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and the Road Traffic Act 1991, as amended, (whether generally or in relation to the Council's area, or part thereof) (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

- 1. The following Orders are hereby revoked:-
 - (a) The County of Wiltshire (Central Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000;
 - (b) The County of Wiltshire (Central Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (Amendment No.1) Order 2002;
 - (c) The County of Wiltshire (Central Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (Amendment No.2) Order 2002;
 - (d) The County of Wiltshire (Various Roads, Salisbury) (Prohibition of Loading and Unloading) Order 1997;
 - (e) The County of Wiltshire (St. Johns Street, Salisbury) (Zone E Amendment) (Tourist Bus Area) Order 2001.
- 2. Save as provided in Articles 6, 7, 10 and 11 to this Order no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Parking Attendant cause or permit any vehicle to wait in any of the lengths of road specified in Schedule 1 to this Order.
- 3. Save as provided in Articles 6, 7, 10 and 11 to this Order no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Parking Attendant cause or permit any vehicle to wait between the hours of 8.00 am and 6.00 pm on any day except Sunday in any of the lengths of road specified in Schedule 2 to this Order.

- 4. Save as provided in Articles 8 and 9 to this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Parking Attendant cause or permit any vehicle to wait in a tourist bus area between the hours of 8.00 am and 6.00 pm on any day on the length of road referred to in Schedule 3 to this Order.
- 5. Save as provided in Articles 6 and 7 to this Order no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Parking Attendant cause or permit any vehicle to load or unload at any time in any of the lengths of road specified in Schedule 4 to this Order.
- 6. Nothing in Articles 2, 3 and 5 to this Order shall prevent any person from causing or permitting a vehicle to wait in any of the lengths of road referred to in those Articles for so long as may be necessary to enable:-
 - (a) a person to board or alight from a vehicle;
 - (b) goods to be loaded onto or unloaded from a vehicle provided that no vehicle shall so wait in any of the lengths of road specified in Schedule 4 to this Order at any time;
 - (c) a vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so referred to or the laying, erection, alteration or repair in or near to any of the said lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 of the Telecommunications Act 1984;
 - (d) a vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of the local authority in pursuance of statutory powers or duties;
 - (e) a vehicle to be used in the service of the Police, Fire Brigade or Ambulance Service in a case of emergency;
- 7. Nothing in Articles 2, 3 and 5 to this Order shall apply to any vehicle:-
 - (i) being used for the purpose of delivering or collecting postal packets as defined in section 87 of the Post Office Act 1953; or
 - (ii) owned by a funeral director or owner of funeral vehicles when used as part of a funeral cortege or otherwise in connection with a funeral; or

- (iii) being licensed as a hackney carriage whilst waiting at a duly authorised taxi rank as marked on the carriageway.
- 8. Nothing in Article 4 to this Order shall prevent any person from causing or permitting a vehicle to wait in a tourist bus area referred to in that Article for so long as may be necessary to enable:-
 - (a) a vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so referred to or the laying, erection, alteration or repair in or near to any of the said lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 of the Telecommunications Act 1984 if the vehicle is being used in the service of a local authority or gas, water, electricity or telecommunications authority in exercise of statutory powers or duties
 - (b) if the vehicle is being used for Police, Fire Brigade or Ambulance purposes; or
 - (d) in any case where the person in control of the vehicle: -
 - (i) is required by law to stop;
 - (ii) is obliged to stop so as to prevent an accident; or
 - (iii) is prevented from proceeding by circumstances beyond his control.
- 9. Nothing in Article 4 of this Order shall render it unlawful for a person to cause or permit a bus to wait in a tourist bus area referred to in that Article:
 - (a) for a period of no longer than 10 minutes; and
 - (b) providing a period of 30 minutes has elapsed since a previous period of waiting by the same vehicle in the same length of road

for the purpose of setting down or picking up passengers and providing the vehicle is not operating a registered local service.

10. Nothing in Articles 2 and 3 to this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc (on which the driver, or other person in charge of the vehicle has marked the time at which the period of waiting began) to wait in any of the lengths of road referred to in those Articles for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length of

- road) provided that this Article shall not apply so as to permit a disabled person's vehicle to wait in any of the lengths of road referred to in Schedule 4.
- 11. Nothing in Articles 2 and 3 to this Order shall prevent any person from causing or permitting any vehicle to wait in any of the lengths of road referred to in those Articles provided permission has been obtained from Salisbury District Council by means of a valid waiver to be displayed in the front or nearside of the vehicle which includes information which enables the driver to be contacted in an emergency and providing that an obstruction is not caused by so doing and that the vehicle is moved if the driver is requested to do so by a Police Officer in uniform or Parking Attendant.
- 12. Where a vehicle has been left in contravention of the restrictions imposed by this Order, a Penalty Charge shall be incurred, the amount of which will be set by Wiltshire County Council under the provisions of the Act of 1991 relating to special parking areas and permitted parking areas.
- Where a Penalty Charge is payable, a Penalty Charge Notice shall be issued by a Parking Attendant in accordance with the requirements of the Act of 1991.
- 14. The Penalty Charge shall be paid within 28 days payable to Salisbury District Council under the terms referred to in the said Notice.
- 15. The prohibition and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the Act as amended or by or under any other enactment.
- 16. In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:-
 - "Disabled Person's Vehicle" means a vehicle lawfully displaying a disabled person's badge;
 - "disabled person's badge" means a badge issued by a local authority in the form prescribed by Regulations 7 and 11 of The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000
 - "parking disc" means a device which -
 - (a) is 125 millimetres square and coloured blue;
 - (b) has been issued by a local authority and has not ceased to be valid; and
 - (c) is capable of showing the quarter hour period during which a period of waiting has begun.

[&]quot;relevant position" means:

- (1) A vehicle displays a disabled persons' badge in the relevant position if:
- (a) the badge is exhibited on the dashboard or facia of the vehicle; or
- (b) where the vehicle is not fitted with a dashboard or facia, the badge is exhibited in a conspicuous position on the vehicle; so that the front of the badge is clearly legible from outside the vehicle.
- (2) A vehicle displays a parking disc in the relevant position if:
- (a) in the case of a vehicle fitted with a dashboard or facia panel, the disc is exhibited thereon so that the quarter-hour period during which the period of waiting began is legible from outside the vehicle; or
- (b) in the case of a vehicle not so fitted, the disc is exhibited in a conspicuous position on the vehicle so that the quarter-hour period during which the period of waiting began is legible from outside the vehicle.

"driver" in relation to a vehicle waiting on-street, means the person driving the vehicle at the time it was left in that position;

"Parking Attendant" has the meaning given by Section 63A of the Road Traffic Regulation Act 1984;

"waiver" means a document issued by Salisbury District Council to exempt a vehicle from waiting where a restriction applies or from a time limit under the terms and charges applicable at the time of issue;

"taxi" has the same meaning given by Regulation 4 of the Traffic Signs Regulations and General Directions 2002 and "taxi rank" means an area of carriageway reserved for use by taxis waiting to pick up passengers.

"tourist bus area" means any area of carriageway of a specified road, intended for the waiting of a bus not operating a registered local service which is comprised within and indicated by a road marking complying with diagram 1028.3 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002;

"bus" has the meaning as in Regulation 22 of the Traffic Signs Regulations and General Directions 2002;

"registered local service" has the meaning as specified in Sections 2 and 6 of the Transport Act 1985;.

12. This Order shall come into operation on 24 May 2004 and shall be cited as The County of Wiltshire (Central Salisbury) (Prohibition and Restriction of Waiting, Loading and Unloading) Order 2004.
