# THE COUNTY OF WILTSHIRE (VARIOUS ROADS, WILTON) (PROHIBITION AND RESTRICTION OF WAITING) ORDER 1983 (AMENDMENT NO 2) ORDER 2004

The Council of the County of Wiltshire in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 63A and Part IV of schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and the Road Traffic Act 1991, as amended, (whether generally or in relation to the Council's area, or part thereof) (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

1. The County of Wiltshire (Various Roads, Wilton) (Prohibition and Restriction of Waiting) Order 1983 (hereinafter referred to as the 'Order of 1983') as amended, shall be further amended by: -

The addition to Schedule 2 of the Order of 1983 of the lengths of road as specified in the Schedule to this Order.

2. This Order shall come into operation on 21 June 2004 and shall be cited as The County of Wiltshire (Various Roads, Wilton) (Prohibition and Restriction of Waiting) Order 1983 (Amendment No 2) Order 2004.




