THE COUNTY OF WILTSHIRE (VARIOUS ROADS, SALISBURY) (PROHIBITION AND RESTRICTION OF WAITING LOADING AND UNLOADING) ORDER 2000 (AMENDMENT NO.11) ORDER 2005

The Council of the County of Wiltshire in exercise of its powers under Sections 1(1), 2(1) to (3), 4, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended, The Road Traffic Act 1991, as amended, (whether generally or in relation to the Council's area, or part thereof) (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

- The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (hereinafter referred to as "the Order of 2000") shall be further amended by:-
 - (a) the addition to the Order of 2000 after "Article 10C" of the following new Article:
 - "10D Save as provided in Articles 18, 19 and 20 of this Order no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Parking Attendant, cause or permit any vehicle to wait in any of the lengths of road specified in Schedule 22 to this Order during the following periods:

Monday - Friday 8 am - 10 am and 4 pm - 6 pm Saturday 8 am - 12 noon

- (b) the addition to the Order of 2000 after Article 17A of the following new Article:
- "17B Save as provided in Articles 18 and 19 of this Order no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Parking Attendant, cause or permit any vehicle to load and unload in any of the lengths of road specified in Schedule 23 to this Order during the following periods:-

Monday to Friday 8 am - 10 am and 4 pm - 6 pm Saturday 8 am - 12 noon

- (c) the deletion from Article 18 of the Order of 2000 of "17A of this Order" and the substitution of "17B of this Order"
- (d) the deletion from Article 18(b)(iii) of the Order of 2000 of "A" after "Schedule 17";

- (e) the addition to the Order of 2000 to Article 18(b) after (iiii) of the following:
 - "(v) any of the lengths of road referred to in Schedule 23 to this Order between the hours of 8 am 10am and 4 pm 6 pm Monday to Friday and between the hours of 8 am 12 noon on Saturdays"
- (f) the deletion from Article 18 of the Order of 2000 of "Schedules 15, 16, 17A and 19 to this Order" and the substitution of "Schedules 15, 16, 17, 19 and 23 to this Order";
- (g) the deletion from Article 19 of the Order of 2000 of "Articles 2 to 17A to this Order" and the substitution of "Articles 2 to 17B to this Order";
- (h) the deletion from Article 20 of the Order of 2000 of "Articles 2 to 10C" and the substitution of "Articles 2 to 10D";
- the deletion from Article 20 of the Order of 2000 of "Schedules 15, 16, 17 and 19" and the substitution of "Schedules 15, 16, 17, 19 and 23"
- the deletion from Articles 3 to 10 of the Order of 2000 of "20 and 22" and the substitution of "and 20"
- (k) the deletion from Schedule 18 of the Order of 2000 of the lengths of road specified in Schedule 1 to this Order;
- (I) the deletion from Schedule 19 of the Order of 2000 of the lengths of road specified in Schedule 2 to this Order;
- (m) the addition as Schedule 22 to the Order of 2000 of the lengths of road specified in Schedule 3 to this Order;
- (n) the addition as Schedule 23 to the Order of 2000 of the lengths of road specified in Schedule 4 to this Order;
- 2. This Order will come into operation on 4 April 2005 and may be cited as The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (Amendment No.11) Order 2005.
