

**WILTSHIRE COUNTY COUNCIL**

**ROAD TRAFFIC REGULATION ACT 1984**

**THE COUNTY OF WILTSHIRE ( VARIOUS ROADS, SALISBURY )**  
**(ONE-WAY) ORDER 2005**

The Council of the County of Wiltshire in exercise of its powers under Sections 1(1), 2(1) to 2(3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

1. The following Orders are hereby revoked:

2. Save as provided in Articles 3 and 4 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden, cause or permit any vehicle to be driven on the lengths of road specified in Column 1 of Schedules 1 and 2 to this Order otherwise than in the direction specified in Column 2 of the said Schedules.
3. Nothing in Article 2 of this Order shall render it unlawful for street cleansing vehicles to operate in any direction on any of the lengths of road specified in Column 1 of Schedules 1 and 2 to this Order.
4. Nothing in Article 2 of this Order shall apply so as to prevent:
  - (a) buses operating a local bus service and with the approval of the Highway Authority;
  - (b) pedal cycles;
  - (c) taxis; and
  - (d) private-hire vehicles

from proceeding in a westerly direction in the bus lane as marked on the carriageway on the length of road specified in Schedule 2 to this Order.

5. In this Order except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:-

“taxi” has the same meaning given by Regulation 4 of The Traffic Signs Regulations and General Directions 2002;

“pedal cycle” has the same meaning given by Regulation 4 of The Traffic Signs Regulations and General Directions 2002;

“bus” has the same meaning given by Regulation 22 of The Traffic Signs Regulations and General Directions 2002;

“Registered Local Service” has the meaning as specified in Sections 2 and 6 of The Transport Act 1985; and

“private hire vehicle” means a vehicle licensed by a Local Authority as a private hire vehicle for the carriage of fare-paying passengers

6. This Order shall come into operation on the 22 April 2005 and may be cited as The County of Wiltshire (Various Roads, Salisbury) (One-Way) Order 2005.

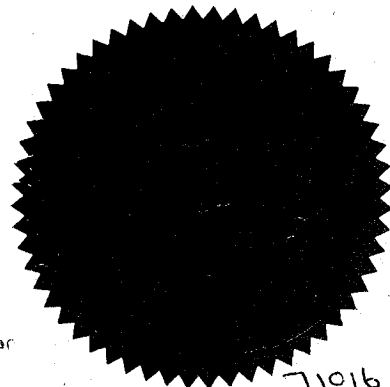
