THE COUNTY OF WILTSHIRE (VARIOUS ROADS, SALISBURY)
(PROHIBITION AND RESTRICTION OF WAITING LOADING AND UNLOADING)
ORDER 2000 (AMENDMENT NO 12) ORDER 2006

The Council of the County of Wiltshire in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and the Road Traffic Act 1991, as amended, (whether generally or in relation to the Council's area, or part thereof) (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

1. The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (hereinafter referred to as "the Order of 2000") as amended, shall be further amended by:
 - (a) The deletion from Schedules 2, 4, 6, 8, and 13 of the Order of 2000 of the lengths of road as specified in Schedule 1 to this Order;
 - (b) The addition to Schedule 2 of the Order of 2000 of the lengths of road as specified in Schedule 2 to this Order.
2. This Order shall come into operation on 10 April 2006 and shall be cited as The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (Amendment No 12) Order 2006.

Longland	Both	From its junction with Wilton Road to a point 18 metres south of that junction

Longland	East	From a point 18 metres south of its junction with Wilton Road to a point 26 metres south of that junction
Longland	West	From a point 18 metres south of its junction with Wilton Road to a point 28 metres south of that junction

	South-west	From a point 24 metres south-east of the centre line of York Road to a point 61 metres south-east of that centre line
Sidney Street	South-east end	The complete length
York Road	North	The complete length
York Road	South	From its junction with Sidney Street to its junction with St. Paul's Roundabout

No Waiting Mon-Fri 8am-6pm

Avon Terrace	South	The complete length

Deletion from Schedule 13 of the Order of 2000

Waiting limited to 2 hours, return prohibited within 2 hours. Mon-Sat 9am-6pm

Fisherton Street	North-east	From a point 13 metres south-east of its junction with St Paul's Road to a point 30 metres south-east of that junction

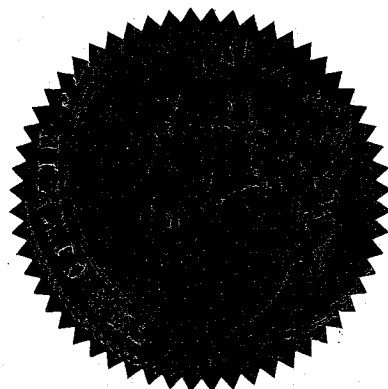

Coldharbour Lane	Both	From the centre line of Ashley Road to a point 21 metres north of that centre line
Devizes Road	North-east	From its junction with Ashley Road to the boundary between Nos. 264/266 Devizes Road
Devizes Road	South-west	From its junction with Hartington Road to the boundary between Nos. 264/266 Devizes Road
Longland	Both	From its junction with Wilton Road to a point 58m south of that junction
