**THE COUNTY OF WILTSHIRE**  
**(SALISBURY) ( RESIDENTS PARKING)**  
**(AMENDMENT) ORDER 2006**

The Council of the County of Wiltshire in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 49, 51, 53 and 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended, and the Road Traffic Act 1991 as amended (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

1. (a) Where the Article in the Orders specified in Schedule 1 to this Order are headed "Application for and Issue of Permits" the heading and the paragraph under that heading shall be deleted and replaced with the following new Article; and
- (b) Where Articles in the Orders specified in Schedule 2 to this Order have the following headings:

Application for and Issue of Permits  
Surrender, Withdrawal and Validity of Permits  
Application for and Issue of Duplicate Permits  
Form of Permits

those headings and the paragraphs contained within those headings shall be deleted and replaced by the following new Article:

**"Application for and Issue of Permits**

Any resident/business eligible to apply for a Permit within a Residents Parking Zone or any visitor eligible to apply for a waiver to exempt a vehicle from waiting where a restriction applies or from a time limit may do so by Application to Salisbury District Council under the terms, conditions and charges applicable at the time of application."

2. In the Schedule headed "Streets or Parts of Streets in the City of Salisbury For The Purpose of the Issue of Permits" in the Orders specified in Schedules 1 and 2 to this Order after the word "Permits" the words "(Subject to Eligibility)" shall be inserted.

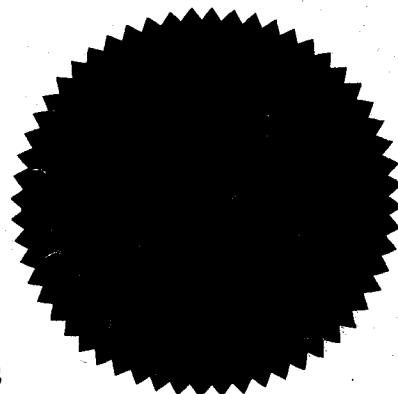
