THE COUNTY OF WILTSHIRE (CENTRAL SALISBURY) (PAY AND DISPLAY STREET PARKING PLACES) ORDER 2004 (AMENDMENT NO. 1) ORDER 2007

The Council of the County of Wiltshire in exercise of its powers under Sections 45, 46, 49, 51, 53, 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and the Road Traffic Act 1991, as amended (whether generally or in relation to the Council's area or part thereof) (hereinafter referred to as "the Act of 1991") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. The County of Wiltshire (Central Salisbury) (Pay and Display Street Parking Places) Order 2004 shall be amended by:-
- (a) The deletion of the existing heading under Schedule 1 of the Order of 2004 and the substitution of a new heading as follows:-

Lengths of Road in Central Salisbury Designated as Parking Places with Pay and Display Machines

<u>Waiting Limited to 1 Hour No Return within 2 Hours</u> <u>Mon - Sat 8 am - 6 pm</u> <u>Sun 10 am - 4 pm</u> (Except Zone A Permit Holders)

(b) The deletion of the existing heading under Schedule 2 of the Order of 2004 and the substitution of a new heading as follows:-

Lengths of Road in Central Salisbury Designated as Parking Places with Pay and Display Machines

<u>Waiting Limited to 1 Hour No Return within 2 Hours</u> <u>Mon - Sat 8 am - 6 pm</u> <u>Sun 10 am - 4 pm</u>

(c) The deletion of the existing heading under Schedule 3 of the Order of 2004 and the substitution of a new heading as follows:-

Lengths of Road in Central Salisbury Designated as Parking Places with Pay and Display Machines

<u>Waiting Limited to 1 Hour No Return within 2 Hours</u> <u>Mon - Fri (except Tuesday) 8 am - 6 pm</u> <u>Sun 10 am - 4 pm</u>

This Order shall come into operation on 22 January 2007 and may be cited as The County of Wiltshire (Central Salisbury) (Pay and Display Street Parking Places) Order 2004 (Amendment No.1) Order 2007.
