

**WILTSHIRE COUNTY COUNCIL**

**ROAD TRAFFIC REGULATION ACT 1984**

**THE COUNTY OF WILTSHIRE (SAXON ROAD, SALISBURY)**  
**(PROHIBITION OF DRIVING) ORDER 2007**

The Council of the County of Wiltshire in exercise of its powers under Sections 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. Save as provided in Article 2 of this Order, no person shall except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden use, or cause or permit to be used, any motor vehicle in such a way that it proceeds along the length of road specified in Schedule 1 to this Order Monday to Friday.
2. Nothing in Article 1 of this Order shall apply so as to prevent any person from causing or permitting any vehicle to proceed on the length of road referred to in Schedule 1 if the vehicle is:
  - (i) Being used in the service of the Local Authority in pursuance of statutory powers or duties or in the services of the Police Authority, Fire Brigade, or Ambulance Service;
  - (ii) Being used in connection with any building operation, or demolition in or adjacent to the road, the removal of any obstruction to traffic in the road, the maintenance, improvement or reconstruction of the road, or the laying, erection, alteration or repair in or adjacent to the road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 of the Telecommunications Act 1984;
  - (iii) Being used to enable the vehicle to be loaded or unloaded while it is in actual use in connection with the repair or maintenance of the properties served by the road;
  - (iv) Being used for or in connection with the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to the road;
  - (v) Displaying a valid permit relating to the length of road specified in the schedule to this Order issued by Salisbury District Council;
  - (vi) A bus being used in the operation as a school bus service in connection with Harnham Infant and Junior Schools;
  - (vii) A taxi being used in the operation as a school service in connection with Harnham Infant and Junior Schools.

3. The Council of the County of Wiltshire is satisfied that for avoiding danger to persons or other traffic using the road to which the Order relates, it is requisite that Section 3(1) of the Act should not apply.
4. In this Order "Taxi" has the same meaning given by Regulation 4 of the Traffic Signs Regulations and General Directions 2002.
5. This Order shall come into operation on the 3 September 2007 and may be cited as The County of Wiltshire (Saxon Road, Salisbury) (Prohibition of Driving) Order 2007.
