The Council of the County of Wiltshire in exercise of its powers under Sections 1, 2, 4, 32, 35, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order.

- The County of Wiltshire (Warminster in the District of West Wiltshire)
 (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street
 Parking) Consolidation Order 2008A shall be amended by the revocation of
 the Map Schedule specified in the First Schedule to this Order and the
 insertion of the Map Schedule specified in the Second Schedule to this Order.
- 2. The effect of the Order will be to: -
 - (a) Remove the existing **No waiting** in Market Place;
 - (b) Remove the existing **No loading** in Market Place;
 - (c) Remove the existing **On-street parking** in Market Place;
 - (d) Amend the existing **No waiting at any time** in Market Place to accommodate e, f and g as follows;
 - (e) Provide **Loading bay areas operating 8am-6pm on any day** on the north side of Market Place from a point 107 metres east of its junction with Weymouth Street to a point 120 metres east of that junction and on the south side of Market Place from a point 84 metres west of its junction with Station Road to a point 95 metres west of that junction and from a point 119 metres west of its junction with Station Road to a point 137 metres west of that junction;
 - (f) Provide a **Disabled parking bay operating at all times** on the north side of Market Place from a point 100 metres east of its junction with Weymouth Street to a point 107 metres east of that junction;
 - (g) Provide a **Taxi rank clearway operating at all times** on the south side of Market Place from a point 79 metres west of its junction with Station Road to a point 84 metres west of that junction.

These restrictions will replace any existing restrictions currently in force on the lengths concerned.

3. This Order shall come into operation on 15th December 2008 and may be cited as The County of Wiltshire (Warminster in the District of West Wiltshire) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking) Consolidation Order 2008A (Amendment No. 1) Order 2008.
