THE COUNTY OF WILTSHIRE (VARIOUS ROADS, SALISBURY) (PROHIBITION AND RESTRICTION OF WAITING LOADING AND UNLOADING) ORDER 2000 (AMENDMENT NO.15) ORDER 2008

The Council of the County of Wiltshire in exercise of its powers under Sections 1(1), 2(1) to (3), 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

- The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (hereinafter referred to as "the Order of 2000") shall be further amended by:-
 - (a) the deletion from Schedule 2 of the Order of 2000 of the lengths of road specified in Schedule 1 to this Order;
 - (b) the addition to Schedule 2 of the Order of 2000 of the lengths of road specified in Schedule 2 to this Order;
 - (c) the addition to Schedule 21 of the Order of 2000 of the length of road specified in Schedule 3 to this Order.
- 2. This Order will come into operation on 1st September 2008 and may be cited as The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (Amendment No.15) Order 2008.

Netherhampton Road	South	From a point in line with the boundary between Nos. 65 and 67 Netherhampton Road to a point in line with the boundary between Nos. 69 and 71 Netherhampton Road
Norfolk Road	North	From a point 15 metres east of its junction with the Norfolk Road Spur to a point 15 metres west of its junction with the Norfolk Road Spur
Norfolk Road (Spur)	Both	From its junction with Netherhampton Road to a point 18 metres south of that junction
Norfolk Road (Spur)	East	From its junction with Norfolk Road to a point 11 metres north that junction
Norfolk Road (Spur)	West	From a point 70 metres south of its junction with Netherhampton Road to its junction with Norfolk Road
Pearce Way – City of Salisbury	Both	From its junction with the Pearce Way Roundabout to its boundary with the Parish of Laverstock
Pearce Way – Laverstock Parish	North-East	From its boundary with the City of Salisbury to a point 158 metres north-west of that boundary
Pearce Way – Laverstock Parish	South-West	From its boundary with the City of Salisbury to a point 148 metres north-west of that boundary
