**THE COUNTY OF WILTSHIRE (VARIOUS ROADS, SALISBURY)**  
**(PROHIBITION AND RESTRICTION OF WAITING LOADING AND UNLOADING)**  
**ORDER 2000 (AMENDMENT NO.16) ORDER 2009**

The Council of the County of Wiltshire in exercise of its powers under Sections 1(1), 2(1) to (3), 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

1. The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (hereinafter referred to as "the Order of 2000") shall be further amended by:-
  - (a) the deletion from Schedule 2 of the Order of 2000 of the lengths of road specified in Schedule 1 to this Order;
  - (b) the deletion from Schedule 4 of the Order of 2000 of the lengths of road specified in Schedule 2 to this Order;
  - (c) the addition to Schedule 2 of the Order of 2000 of the lengths of road specified in Schedule 3 to this Order.
2. This Order will come into operation on 7<sup>th</sup> September 2009 and may be cited as The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (Amendment No.16) Order 2009.

**SCHEDULE 1**

**Deletions from Schedule 2 of the Order of 2000**

**No Waiting At Any Time**

<b><u>Road</u></b>	<b><u>Side</u></b>	<b><u>Description</u></b>
Campbell Road	South	From a point 142 metres north-west of its junction with St. Mark's Avenue to a point 148 metres north-west of that junction
Hollows Close	Both	From its junction with Harnham Road to a point 26 metres south of the northern boundary of Harnham Road
St. Mark's Avenue	Both	From its junction with St. Mark's Roundabout on Churchill Way to a point in line with the boundary between Nos. 15 and 17 St. Mark's Avenue

## SCHEDULE 2

### Deletions from Schedule 4 of the Order of 2000

No Waiting Monday – Saturday 9.00 am – 6.00 pm

<u>Road</u>	<u>Side</u>	<u>Description</u>
St. Mark's Avenue	East	From a point in line with the boundary between Nos. 15 and 17 St. Mark's Avenue to a point 15 metres north of its junction with Grange Gardens
St. Mark's Avenue	West	From a point in line with the boundary between Nos. 15 and 17 St. Mark's Avenue to its junction with Campbell Road


## SCHEDULE 3

### Additions to Schedule 2 of the Order of 2000


No Waiting At Any Time

<u>Road</u>	<u>Side</u>	<u>Description</u>
Hollows Close	Both	From its junction with Harnham Road to a point in line with the boundary between Nos. 4 and 6 Hollows Close
Hollows Close	East & North	From its junction with Hollows Close (Eastern Spur) to a point in line with the boundary between Nos. 41 and 43 Hollows Close
Hollows Close	West & South	From a point 14 metres south of its junction with Hollows Close (Eastern Spur) to its junction with Hollows Close (Southern Spur)
Spire View	Both	The complete length
