THE COUNTY OF WILTSHIRE (CENTRAL SALISBURY) (PROHIBITION AND RESTRICTION OF WAITING LOADING AND UNLOADING) ORDER 2004 (AMENDMENT NO. 1) ORDER 2010

The Council of the County of Wiltshire in exercise of its powers under Sections 1, 2, 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and The Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

- The County of Wiltshire (Central Salisbury) (Prohibition and Restriction of Waiting, Loading and Unloading) Order 2004 (hereinafter referred to as "the Order of 2004") shall be amended by: -
 - (a) The deletion from Schedule 1 of the Order of 2004 of the lengths of road specified in Schedule 1 to this Order;
 - (b) The deletion from Schedule 4 of the Order of 2004 of the lengths of road specified in Schedule 2 to this Order;
 - (c) The addition to Schedule 1 of the Order of 2004 of the lengths of road specified in Schedule 3 to this Order;
 - (d) The addition to Schedule 4 of the Order of 2004 of the lengths of road specified in Schedule 4 to this Order.
- 2. This Order shall come into operation on 15th February 2010 and shall be cited as The County of Wiltshire (Central Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2004 (Amendment No. 1) Order 2010.

Deletions from Schedule 1 of the Order of 2004

Catherine Street	East	From its junction with Milford Street to a point 2 metres south of a point in line with the boundary between Nos. 55 and 57 Catherine Street
Catherine Street	East	From a point 6 metres south of a point in line with the boundary between Nos. 55 and 57 Catherine Street to its junction with Ivy Street
Chipper Lane	Both	From its junction with Castle Street to a point 21 metres east of that junction
Chipper Lane	North	From its junction with Endless Street to a point 17 metres west of that junction
Winchester Street	South	From a point 41 metres east of its junction with Rollestone Street to a point 48 metres east of that junction
Winchester Street	South	From its junction with Rollestone Street to a point 18 metres east of that junction
