THE COUNTY OF WILTSHIRE (CENTRAL SALISBURY)
(STREET PARKING PLACES) ORDER 2004 (AMENDMENT NO. 1) ORDER 2010

The Council of the County of Wiltshire in exercise of its powers under Sections 1, 2, 32 and 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. The County of Wiltshire (Central Salisbury) (Street Parking Places) Order 2004 (hereinafter referred to as "the Order of 2004") shall be amended by: -
 - (a) The deletion from Schedule 2 of the Order of 2004 of the lengths of road specified in Schedule 1 to this Order;
 - (b) The deletion from Schedule 3 of the Order of 2004 of the lengths of road specified in Schedule 2 to this Order;
 - (c) The addition to Schedule 3 of the Order of 2004 of the length of road specified in Schedule 3 to this Order.
2. This Order shall come into operation on 15th February 2010 and may be cited as The County of Wiltshire (Central Salisbury) (Street Parking Places) Order 2004 (Amendment No. 1) Order 2010.

SCHEDULE 1

Deletions from Schedule 2 of the Order of 2004

Motor Cycle Only Parking
Waiting Limited 1 hour With Return Prohibited Within 2 hours
Mon-Sat 8am-6pm

<u>Road</u>	<u>Side</u>	<u>Description</u>
Catherine Street	East	From a point 2 metres south of a point in line with the boundary between Nos. 55 and 57 Catherine Street to a point 6 metres south of a point in line with the boundary between Nos. 55 and 57 Catherine Street
Milford Street	South	From a point 42 metres west of a point in line with the boundary between Nos. 10 and 12 Milford Street to a point 13 metres west of the western boundary of the Red Lion Hotel

SCHEDULE 2

Deletions from Schedule 3 of the Order of 2004

Disabled Parking Places Operating Every Day At All Times
With Waiting Limited to 3 hours, No Return Within 3 hours
Mon-Sat 8am-6pm

<u>Road</u>	<u>Side</u>	<u>Description</u>
Chipper Lane	North	From a point 21 metres east of its junction with Castle Street to a point 34 metres east of that junction
Endless Street	West	From a point 4 metres south of a point in line with the boundary between No. 52 Blue Boar Row and No. 1 Endless Street to a point 3 metres south of a point in line with the boundary between Nos. 1 and 3 Endless Street
