**THE COUNTY OF WILTSHIRE (CENTRAL SALISBURY)**  
**(TAXI RANK CLEARWAYS) ORDER 2004 (AMENDMENT NO. 1) ORDER 2010**

The Council of the County of Wiltshire in exercise of its powers under sections 1, 2 and 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby makes the following Order.

1. The County of Wiltshire (Central Salisbury) (Taxi Rank Clearways) Order 2004 (hereinafter referred to as "the Order of 2004") shall be amended by: -
  - (a) The deletion from Schedule 3 of the Order of 2004 of the length of road specified in Schedule 1 to this Order;
  - (b) The addition to Schedule 3 of the Order of 2004 of the length of road specified in Schedule 2 to this Order
2. This Order shall come into operation on 15<sup>th</sup> February 2010 and may be cited as The County of Wiltshire (Central Salisbury) (Taxi Rank Clearways) Order 2004 (Amendment No. 1) Order 2010.

**SCHEDULE 1**

**Deletion from Schedule 3 of the Order of 2004**

**Taxi Rank Clearway Midnight – 8am and 6pm – Midnight on any day**

<b><u>Road</u></b>	<b><u>Side</u></b>	<b><u>Description</u></b>
Endless Street	West	From a point 4 metres south of a point in line with the boundary between No. 52 Blue Boar Row and No. 1 Endless Street to a point 5 metres north of a point in line with the northern boundary of No. 3 Endless Street

**SCHEDULE 2**

**Addition to Schedule 3 of the Order of 2004**

**Taxi Rank Clearway Midnight – 8am and 6pm – Midnight on any day**

<b><u>Road</u></b>	<b><u>Side</u></b>	<b><u>Description</u></b>
Endless Street	West	From a point 4 metres south of a point in line with the boundary between No. 52 Blue Boar Row and No.1 Endless Street to a point 11 metres north of a point in line with the boundary between No. 52 Blue Boar Row and No. 1 Endless Street
