THE COUNTY OF WILTSHIRE (VARIOUS ROADS, SALISBURY)
(PROHIBITION AND RESTRICTION OF WAITING LOADING AND UNLOADING)
ORDER 2000 (AMENDMENT NO.19) ORDER 2010

The Council of the County of Wiltshire in exercise of its powers under Sections 1(1), 2(1) to (3), 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

1. The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (hereinafter referred to as "the Order of 2000") shall be further amended by:-
 - (a) the addition to Schedule 2 of the Order of 2000 of the lengths of road specified in Schedule 1 to this Order;
 - (b) the addition to Schedule 21 of the Order of 2000 of the lengths of road specified in Schedule 2 to this Order.
2. This Order will come into operation on 4th May 2010 and may be cited as The County of Wiltshire (Various Roads, Salisbury) (Prohibition and Restriction of Waiting Loading and Unloading) Order 2000 (Amendment No.19) Order 2010.

SCHEDULE 1

Additions to Schedule 2 of the Order of 2000

No Waiting At Any Time

<u>Road</u>	<u>Side</u>	<u>Description</u>
Bedford Road	North-west	From a point in line with the boundary between Nos. 14 and 16 Bedford Road to a point in line with the north-eastern boundary wall of No. 18 Bedford Road
Bouverie Avenue	North-east	From its junction with Coombe Road to a point in line with the south-eastern boundary wall of No. 10 Bouverie Avenue
Bouverie Avenue	North-east	From a point in line with the boundary between Nos. 42 and 44 Bouverie Avenue to a point in line with the boundary between Nos. 46 and 48 Bouverie Avenue

SCHEDULE 1 (continued)

Bouverie Avenue	South-west	From its junction with Coombe Road to a point in line with the boundary between No. 1 Bouverie Avenue and No. 122 Coombe Road
Bouverie Avenue	South-west	From a point in line with the boundary between Nos. 13 and 15 Bouverie Avenue to a point in line with the boundary between Nos. 46 and 48 Bouverie Avenue
Cecil Avenue	Both	From its junction with Meyrick Avenue to a point 10 metres west of that junction
Coombe Road	North-west	From a point in line with the boundary between Nos. 150 and 152 Coombe Road to a point in line with the boundary between Nos. 154 and 156 Coombe Road
Héronswood	North	From its junction with Odstock Road to its junction with Swiftdown
Héronswood	South	From its junction with Odstock Road to its junction with Lennetsdene
Meyrick Avenue	Both	From its junction with Bouverie Avenue to a point 10 metres south of that junction
Meyrick Avenue	Both	From its junction with Coombe Road to a point 10 metres north of that junction
Meyrick Avenue	East	From a point 10 metres north of its junction with Cecil Avenue to a point in line with the boundary between the property called Hillcrest (Meyrick Avenue) and No. 152 Coombe Avenue
Meyrick Avenue	West	From a point 10 metres north of its junction with Cecil Avenue to a point 10 metres south of its junction with Cecil Avenue
Russell Road	North-east	From its junction with Bedford Road to a point 7 metres north-west of that junction
Russell Road	South-west	From its junction with Bedford Road to a point 12 metres north-west of that junction

Héronswood	North	From its junction with Swiftdown to a point 10 metres west of a point in line with the boundary between Nos. 25 and 27 Ravenscroft
Héronswood	South	From its junction with Linnetsdene to a point 10 metres west of a point in line with the boundary between Nos. 25 and 27 Ravenscroft
