THE COUNTY OF WILTSHIRE (CENTRAL SALISBURY)
(LOADING BAY AREAS) ORDER 2004 (AMENDMENT NO. 3) ORDER 2010

The Council of the County of Wiltshire in exercise of its powers under Sections 1, 2, 4, 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("hereinafter referred to as "the Act of 1984") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. The County of Wiltshire (Central Salisbury) (Loading Bay Areas) Order 2004 as amended, (hereinafter referred to as "the Order of 2004") shall be further amended by: -
 - (a) The deletion from Schedule 2 of the Order of 2004 of the lengths of road specified in Schedule 1 to this Order;
 - (b) The addition to Schedule 2 of the Order of 2004 of the lengths of road specified in Schedule 2 to this Order.
2. This Order shall come into operation on 1st June 2010 and may be cited as The County of Wiltshire (Central Salisbury) (Loading Bay Areas) Order 2004 (Amendment No. 3) Order 2010.

SCHEDULE 1

Deletions from Schedule 2 of the Order of 2004

Loading Bay Areas in which Loading/Unloading is permitted
8.00 am – 6.00 pm on any day

<u>Road</u>	<u>Side</u>	<u>Description</u>
Milford Street	Both	From a point 22 metres west of a point in line with the boundary between Nos. 10 and 12 Milford Street to a point 32 metres west of a point in line with the boundary between Nos. 10 and 12 Milford Street
New Canal	North	From a point in line with the western boundary of No. 10 New Canal to a point 12 metres west of a point in line with the western boundary of No.10 New Canal

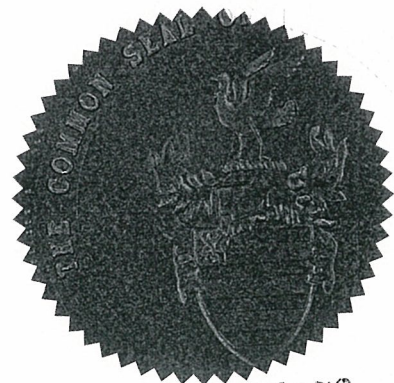
SCHEDULE 2

Additions to Schedule 2 of the Order of 2004

Loading Bay Areas in which Loading/Unloading is permitted
8.00 am – 6.00 pm on any day

<u>Road</u>	<u>Side</u>	<u>Description</u>
Fisherton Street	North-East	From a point in line with the south eastern boundary wall of No. 16 Fisherton Street to a point in line with the south eastern boundary wall of No. 18 Fisherton Street
Milford Street	North	From a point 15 metres east of a point in line with the western boundary wall of the Cathedral Hotel to a point 27 metres east of a point in line with the western boundary wall of the Cathedral Hotel
Milford Street	South	From a point 22 metres west of a point in line with the boundary between Nos. 10 and 12 Milford Street to a point 32 metres west of a point in line with the boundary between Nos. 10 and 12 Milford Street
New Canal Service Road	North	From a point 25 metres east of a point in line with the boundary between Nos. 40 and 42 New Canal to a point 37 metres east of a point in line with the boundary between Nos. 40 and 42 New Canal
New Canal Service Road	North	From a point in line with the western boundary of No. 10 New Canal to a point 12 metres west of a point in line with the western boundary of No. 10 New Canal
New Canal Service Road	West	From a point 4 metres north of its junction with New Canal to a point 14 metres north of that junction
New Canal Service Road (Northern Spur)	West	The complete length
