THE COUNTY OF WILTSHIRE (SALISBURY – ZONE G – HARNHAM)
(PROHIBITION AND RESTRICTION OF WAITING) ORDER 2008
(AMENDMENT NO.1) ORDER 2011

The Council of the County of Wiltshire in exercise of its powers under Sections 1, 2, 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and The Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. The County of Wiltshire (Salisbury – Zone G – Harnham) (Prohibition and Restriction of Waiting) Order 2008 (hereinafter referred to as "the Order of 2008") shall be amended by: -
 - (a) The deletion from Schedule 2 of the Order of 2008 of the lengths of road specified in Schedule 1 to this Order;
 - (b) The addition to Schedule 2 of the Order of 2008 of the length of road specified in Schedule 2 to this Order.
2. This Order shall come into operation on 1st December 2011 and shall be cited as The County of Wiltshire (Salisbury – Zone G – Harnham) (Prohibition and Restriction of Waiting) Order 2008 (Amendment No.1) Order 2011.

SCHEDULE 1

Deletions from Schedule 2 of the Order of 2008

No Waiting Monday – Saturday 8.00 am – 6.00 pm

<u>Road</u>	<u>Side</u>	<u>Description</u>
Downton Road	North-East	From a point in line with the north-western boundary wall of No. 21 Downton Road to a point in line with the boundary between Nos. 41 and 43 Downton Road
Downton Road	North-East	From a point in line with the boundary between Nos. 47 and 49 Downton Road to a point in line with the boundary between Nos. 49 and 51 Downton Road




