THE COUNTY OF WILTSHIRE (SALISBURY) (PROHIBITION AND RESTRICTION  
OF WAITING, TAXI RANK CLEARWAYS AND ON STREET PARKING)  
CONSOLIDATION ORDER 2013 EXPERIMENTAL ORDER 2013

The Council of the County of Wiltshire in exercise of its powers under Sections 9, 10 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order.

1. The County of Wiltshire (Salisbury) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking) Consolidation Order 2013 shall be amended by the suspension of the Map Schedules specified in the First Schedule to this Order and the insertion of the Map Schedules specified in the Second Schedule to this Order for the duration of this Experimental Order.
2. The effect of the Order will be: -
  - (a) To introduce **Disabled parking Mon-Sat 8am-6pm 3 hours No return within 3 hours** as follows;  
**Milford Street** – south side – outside of Specsavers  
**Minster Street** – west side – for a length of 7 metres, outside of Nos. 3-13 Minster Street  
**New Canal** – south side – for a length of 20 metres, outside of Nos. 47-53 New Canal  
**Silver Street** – for a length of 14 metres outside of the Boots premises
  - (b) To introduce **No waiting Sat 6pm – Midnight and Sun Midnight – 6am** to the existing Pay and Display parking bays on;  
**Milford Street** – north side – outside of Nos. 13-19 Milford Street  
**Milford Street** – south side – outside of Nos. 2-10 and 22-23 Milford Street
  - (c) To introduce **No waiting Sat 10pm – Midnight and Sun Midnight – 6am** to the existing Pay and Display parking bays on the north side of **Milford Street** outside of Nos. 22-34 Milford Street
  - (d) To introduce **No waiting Sat 6pm – Midnight and Sun Midnight – 6am** to the existing loading bays as follows:  
**Milford Street** – north side – outside of The Cathedral Hotel  
**Milford Street** – south side – outside of The Red Lion Hotel
  - (e) To introduce **No waiting at any time** and **No loading at any time** on the north side of **New Canal** outside of the Boots premises and the Burger King premises
  - (f) To introduce **Loading only 8am – 6pm** on the south side of **New Canal** for a length of 15 metres outside of Nos. 53-57 New Canal
  - (g) To extend the **No stopping at any time** except taxi on **Castle Street** for 16 metres in a southerly direction
  - (h) To extend the existing **Disabled parking Mon-Sat 8am-6pm 3 hours No return within 3 hours** on the north side of **Winchester Street** by 7 metres at its eastern end

The above restrictions will replace any existing restrictions currently in force in Salisbury on the lengths of road concerned for the duration of this Experimental Order.

3. The Director of Highways, or a person authorised by him, may modify or suspend the operation of this Order, or any provision of it if it appears to him essential:
- (a) in the interests of the expeditious, convenient and safe movement of traffic;
  - (b) in the interests of providing suitable and adequate on-street parking facilities; or
  - (c) for preserving or improving the amenities of the area through which an road affected by the Order runs.
4. This Order shall come into operation on 8<sup>th</sup> April 2013 and may be cited as The County of Wiltshire (Salisbury) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking) Consolidation Order 2013 Experimental Order 2013.


