

**WILTSHIRE COUNCIL****ROAD TRAFFIC REGULATION ACT 1984**  
**TRAFFIC MANAGEMENT ACT 2004****THE COUNTY OF WILTSHIRE (VARIOUS ROADS, TISBURY) (STREET PARKING PLACES) ORDER 2003 (AMENDMENT NO.1) ORDER 2013**

The Council of the County of Wiltshire in exercise of its powers under Sections 32(1), 35(1), 63A and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and The Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. The County of Wiltshire (Various Roads, Tisbury) (Street Parking Places) Order 2003 (hereinafter referred to as "the Order of 2003") shall be amended as follows:
  - (a) The deletion from Schedule 1 of the Order of 2003 of the length of road specified in Schedule 1 to this Order.
  - (b) The addition to Schedule 1 of the Order of 2003 of the lengths of road specified in Schedule 2 to this Order.
  
2. This Order shall come into operation on 13<sup>th</sup> September 2013 and shall be cited as The County of Wiltshire (Various Roads, Tisbury) (Street Parking Places) Order 2003 (Amendment No.1) Order 2013.

**SCHEDULE 1****Deletion to Schedule 1 of the Order of 2003**

**Waiting Limited 1 hour, no return within 2 hours Mon-Sat 8am-6pm**

<b><u>Road</u></b>	<b><u>Side</u></b>	<b><u>Description</u></b>
High Street	south-west	From a point 3 metres south-east of its junction with Beckett Street for a distance of 27 metres in a south-easterly direction

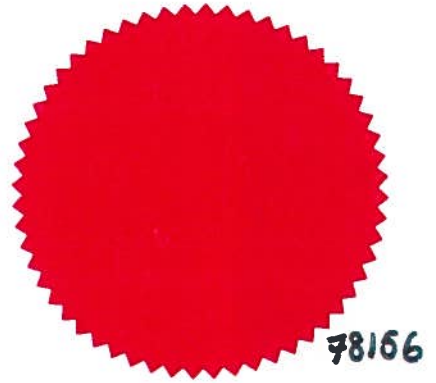
**Additions to Schedule 1 of the Order of 2003**
