THE COUNTY OF WILTSHIRE (DEVIZES) (PROHIBITION AND RESTRICTION OF WAITING, TAXI RANK CLEARWAYS AND ON STREET PARKING) CONSOLIDATION ORDER 2009 EXPERIMENTAL ORDER 2014

The Council of the County of Wiltshire in exercise of its powers under Sections 9, 10 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order.

1. The County of Wiltshire (Devizes) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking) Consolidation Order 2009 shall be amended by the suspension of the Map Schedule specified in the First Schedule to this Order and the insertion of the Map Schedule specified in the Second Schedule to this Order for the duration of this Experimental Order.

2. The effect of the Order will be: -

- (a) To introduce **Bus parking 9am-6pm 20mins No return within 1 hour** on:-

New Park Street – north eastern side – from a point 10 metres south east of a point in line with its junction with New Park Road to a point 28 metres south east of that junction

New Park Street – south western side – from a point 19 metres south east of a point in line with New Park Road to a point 37 metres south east of that junction

- (b) To introduce **No waiting at any time** on:-

New Park Street – north eastern side – from a point 8 metres south east of a point in line with its junction with New Park Road to a point 10 metres south of that junction; from a point 28 metres south east of a point in line with its junction with New Park Road to a point 31 metres south east of that junction

New Park Street – south western side – from a point 37 metres south east of a point in line with its junction with New Park Road to a point 39 metres south east of that junction

The above restrictions will replace any existing restrictions currently in force in Devizes on the lengths of road concerned for the duration of this Experimental Order.

3. The Consolidation Order shall be amended by inserting the following definition of "bus" under paragraph 3(1):-

"bus" has the meaning as defined in the Traffic Signs Regulations and General Direction 2002

4. The Director of Highways, or a person authorised by him, may modify or suspend the operation of this Order, or any provision of it if it appears to him essential:

- (a) in the interests of the expeditious, convenient and safe movement of traffic;

- (b) in the interests of providing suitable and adequate on-street parking facilities; or
- (c) for preserving or improving the amenities of the area through which an road affected by the Order runs.
5. This Order shall come into operation on 17th March 2014 and may be cited as The County of Wiltshire (Devizes) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking) Consolidation Order 2009 Experimental Order 2014.
