THE COUNTY OF WILTSHIRE (SALISBURY) (PROHIBITION AND RESTRICTION OF WAITING, TAXI RANK CLEARWAYS AND ON STREET PARKING) CONSOLIDATION ORDER 2013 (AMENDMENT NO.8) ORDER 2014

The Council of the County of Wiltshire in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 49, 51, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order.

- 1. The County of Wiltshire (Salisbury) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking) Consolidation Order 2013 Experimental Order No.2 2013 is hereby revoked.
- 2. The County of Wiltshire (Salisbury) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking) Consolidation Order 2013 shall be amended by the revocation of the Map Schedules specified in the First Schedule to this Order and the insertion of the Map Schedules specified in the Second Schedule to this Order.
- 3. The effect of the Order will be: -
 - (a) To introduce No waiting at any time and No loading at any time on the following lengths of road: -Endless Street – west side – from a point 10 metres north of its junction with Blue Boar Row to a point 11 metres north of that junction Milford Street – north side – from a point 41 metres east of a point in line with the western boundary wall of the Cathedral Hotel to a point in line with the boundaries between Nos. 10 and 12 Milford Street
 - (b) To introduce Loading only 8am 6pm and No waiting Saturday 6pm Midnight and Sunday Midnight 6am on the north side of Milford Street from a point in line with the western boundary wall of the Cathedral Hotel to a point 12 metres east of that boundary
 - (c) To introduce **Loading only 8am 6pm** on the north side of **New Canal** from a point 30 metres west of its junction with Queen Street to a point 44 metres west of that junction
 - (d) To introduce **No waiting except taxis** on the north side of **New Canal** from a point 9 metres west of its junction with Queen Street to a point 30 metres west of that junction
 - (e) Administrative change in New Canal to update restrictions previously mapped.

These restrictions will replace any existing restrictions currently in force in the city of Salisbury.

4. This Order shall come into operation on 28th July 2014 and may be cited as The County of Wiltshire (Salisbury) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking) Consolidation Order 2013 (Amendment No.8) Order 2014.
