THE COUNTY OF WILTSHIRE (WESTERN WILTSHIRE) (OFF STREET PARKING PLACES) ORDER 2011 (AMENDMENT NO.1) ORDER 2015

The Council of the County of Wiltshire in exercise of its powers under Sections 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended ("the 1984 Act") and the Traffic Management Act 2004, as amended ("the 2004 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order.

- 1. The County of Wiltshire (Western Wiltshire) (Off Street Parking Places) Order 2011, (hereinafter referred to as "the Order of 2011") shall be amended by:-
 - (a) The addition to Schedule 1 of the Order of 2011 of the off street parking places specified in Schedule 1 to this Order;
 - (b) The addition of the following article:
 - '30A. Where in Schedule 1 to this Order a Parking Place is described as available for Parking Permits only, no person shall permit a vehicle to wait in that Parking Place unless the vehicle has been issued a Parking Permit for that Parking Place by the Council.'
 - (c) Removing the current interpretation of Parking Permit and replacing it with the following wording:
 - "Parking Permit" means a permit issued by the Council (or a parking permit, season ticket or off-street residents permit of a type and design as outlined in Schedule 2), for such periods as the Council shall determine from time to time on payment of the appropriate fee, for a Vehicle of a specific class and for a specific Parking Place(s) and subject to such terms and conditions as determined by the Council from time to time as set out in the Terms and Conditions of Use, in force at the time.
 - (d) The addition of the following interpretation:
 - "Minibus" has the meaning defined in Section 3 of The Road Vehicles (Construction And Use) Regulations 1986
- This Order shall come into operation on 1st March 2015 and may be cited as The County of Wiltshire (Western Wiltshire) (Off Street Parking Places)
 Order 2011 (Amendment No.1) Order 2015.
