THE COUNTY OF WILTSHIRE (DEVIZES) (PROHIBITION AND RESTRICTION OF  
WAITING, TAXI RANK CLEARWAYS AND ON STREET PARKING)  
CONSOLIDATION ORDER 2009 (AMENDMENT NO.6) ORDER 2015

The Council of the County of Wiltshire in exercise of its powers under Sections 1, 2, 4, 32, 35, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order.

1. The County of Wiltshire (Devizes) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking) Consolidation Order 2009 Experimental Order 2014 is hereby revoked.
2. The County of Wiltshire (Devizes) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking) Consolidation Order 2009 shall be amended by the revocation of the Map Schedule specified in the First Schedule to this Order and the insertion of the Map Schedule specified in the Second Schedule to this Order.
3. The effect of the Order will be: -
  - (a) To introduce **Bus parking 9am-6pm 20mins No return within 1 hour** on;  
**New Park Street** – north eastern side – from a point 10 metres south east of a point in line with its junction with New Park Road to a point 28 metres south east of that junction  
**New Park Street** – south western side – from a point 19 metres south east of a point in line with New Park Road to a point 37 metres south east of that junction
  - (b) To introduce **No waiting at any time** on;  
**New Park Street** – north eastern side – from a point 8 metres south east of a point in line with its junction with New Park Road to a point 10 metres south of that junction; from a point 28 metres south east of a point in line with its junction with New Park Road to a point 31 metres south east of that junction  
**New Park Street** – south western side – from a point 37 metres south east of a point in line with its junction with New Park Road to a point 39 metres south east of that junction

These restrictions will replace any existing restrictions currently in force in the town of Devizes.

4. The Consolidation Order shall be amended by inserting the following definition of "bus" under paragraph 3(1):-

"bus" has the meaning as defined in the Traffic Signs Regulations and General Directions 2002

5. This Order shall come into operation on 8<sup>th</sup> June 2015 and may be cited as The County of Wiltshire (Devizes) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking) Consolidation Order 2009 (Amendment No.6) Order 2015.
