THE COUNTY OF WILTSHIRE (MELKSHAM AND MELKSHAM WITHOUT) (PROHIBITION AND RESTRICTION OF WAITING, TAXI RANK CLEARWAYS AND ON STREET PARKING) CONSOLIDATION ORDER 2012 (AMENDMENT NO.2) ORDER 2015

The Council of the County of Wiltshire in exercise of its powers under Sections 1, 2, 4, 32, 35, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order.

- 1. The County of Wiltshire (Melksham and Melksham Without) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking)
 Consolidation Order 2012 shall be amended by the revocation of the Map Schedules specified in the First Schedule to this Order and the insertion of the Map Schedules specified in the Second Schedule to this Order.
- 2. The effect of the Order will be to:
 - (a) introduce **No waiting at any time** on the following lengths of road:

Corsham Road – west side – from a point 12 metres north of its junction with First Lane to a point 30 metres south of that junction

First Lane – both sides – from its junction with Corsham Road for a distance of 25 metres in a westerly direction

Lavender Close – both sides – from its junction with Snowberry Lane for a distance of 5 metres in a north westerly direction

Snowberry Lane – both sides – from its junction with Spa Road to its junction with the new relief road (a distance of approximately 520 metres)

- (b) Revoke existing Parking Mon Sat 8am-6pm 1 hour No return within 1 hour on the south west side of Bath Road from a point 65 metres north of its junction with Old Broughton Road to a point 25 metres south of its junction with Bell Court.
- 3. This Order shall come into operation on 28th September 2015 and may be cited as The County of Wiltshire (Melksham and Melksham Without) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking) Consolidation Order 2012 (Amendment No.2) Order 2015.
