# THE COUNTY OF WILTSHIRE (CALNE AND CALNE WITHOUT) (PROHIBITION AND RESTRICTION OF WAITING, TAXI RANK CLEARWAYS AND ON STREET PARKING) CONSOLIDATION ORDER 2015 (AMENDMENT NO.1) ORDER 2015

The Council of the County of Wiltshire in exercise of its powers under Sections 1, 2, 4, 32, 35, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order.

- 1. The County of Wiltshire (Calne and Calne Without) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking)
  Consolidation Order 2015 shall be amended by the revocation of the Map Schedule specified in the First Schedule to this Order and the insertion of the Map Schedule specified in the Second Schedule to this Order.
- 2. The effect of the Order will be to introduce **No waiting at any time** on the following lengths of road: -

Abberd Way – north side – from a point 23 metres west of its junction with The Knapp to a point 16 metres east of its junction with Ogilvie Square

Abberd Way – south side – from a point 26 metres west of its junction with The Knapp to a point 28 metres east of that junction; from a point 28 metres west of its junction with Penn Hill Road to a point 6 metres west of that junction; from a point 16 metres east of its junction with Penn Hill Road to a point 16 metres east of its junction with Ogilvie Square

**The Knapp** – both sides – from its junction with Abberd Way to a point 10 metres south of that junction

**Penn Hill Road** – both sides – from its junction with Abberd Way to a point 10 metres north of that junction

**Ogilvie Square** – both sides – from its junction with Abberd Way to a point 10 metres south of that junction

These restrictions will replace any existing restrictions currently in force in the town of Calne.

This Order shall come into operation on 4<sup>th</sup> November 2015 and may be cited as The County of Wiltshire (Calne and Calne Without) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking)
Consolidation Order 2015 (Amendment No.1) Order 2015.
