

The Council of the County of Wiltshire in exercise of its powers under Sections 1, 2, 4, 32, 35, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") as amended and the Traffic Management Act 2004 (hereinafter referred to as "the Act of 2004") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order.

- 1. The County of Wiltshire (Chippenham and Chippenham Without) (Prohibition and Restriction of Waiting, Prohibition of Stopping, Clearways and On Street Parking) Consolidation Order 2019 shall be amended by the revocation of the Map Schedules specified in the First Schedule to this Order and the insertion of the Map Schedules specified in the Second Schedule to this Order.
- 2. The effect of the Order will be as follows:

a) To remove **No waiting at any time** on the following length of road: **New Road** – east side – from a point 46 metres south west of its junction with Foundry Lane for a distance of 14 metres in a south westerly direction

b) To remove **Parking Monday to Saturday 8am – 6pm 1 hour No return within 1 hour** on the following length of road:

Park Lane - north side – from a point 15 metres west of its junction with Malmesbury Road for a distance of 12 metres in a westerly direction

c) To introduce **No Waiting at any time** on the following lengths of roads:

Foundry Lane – north side – from a point opposite the eastern access to Hathaway Retail Park for a distance of 134 metres in a north easterly direction

Foundry Lane – south side – from the eastern access to Hathaway Retail Park for a length of 43 metres in an easterly direction

Foundry Lane – south side – from a point 62 metres east of the eastern access to Hathaway Retail Park for a distance of 75 metres in a north easterly direction

Park Lane – north side – from its junction with Malmesbury Road for a distance of 27 metres in a westerly direction

d) To introduce **Parking Monday to Saturday 8am – 6pm 1 hour No return with 1 hour** on the following length of road:

New Road – east side – from the existing 1 hour parking bay for a length of 5 metres in a south westerly direction

New Road – east side – from a point 46 metres south west of its junction with Foundry Lane for a distance of 14 metres in a south westerly direction

e) To introduce Loading Only 8am – 6pm on the following length of road:

Foundry Lane – south side – from a point 42 metres east of the eastern access to Hathaway Retail Park for a distance of 20 metres in a north easterly direction

These restrictions will replace any existing restrictions currently in force in the Town of Chippenham.

3. This Order shall come into operation on 2nd December 2019 and may be cited as The County of Wiltshire (Chippenham and Chippenham Without) (Prohibition and Restriction of Waiting, Prohibition of Stopping, Clearways and On Street Parking) Consolidation Order 2019 (Amendment No.1) Order 2019.

NOTICE OF PENALTY CHARGES

CIVIL ENFORCEMENT AREAS AND SPECIAL ENFORCEMENT AREAS IN THE DISTRICTS OF KENNET, NORTH WILTSHIRE AND SALISBURY

NOTICE IS HEREBY GIVEN that Wiltshire County Council in accordance with its powers under the Traffic Management Act 2004 and in consultation with the Secretary of State for Transport has amended the level of Penalty Charges in the designated parking areas in the Districts of Kennet, North Wiltshire and Salisbury. These relate to the Civil Enforcement of on-street parking contraventions for waiting/loading and parking restrictions.

Two levels of Penalty Charge have been set for different contraventions (previously one level which was £60). The Penalty Charges are £70 on the issue of a Penalty Charge Notice ("PCN") for Higher Level contraventions and £50 on the issue of a PCN for Lower Level contraventions in accordance with The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 but discounted by 50% if payment is received within 14 days of the issue of the PCN (as before) or if payment is received within 21 days for contraventions detected with a camera (approved device).

On the issue of a Charge Certificate in accordance with The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007 the penalty charge will be increased by 50% (as before).

The above charges will come into effect on 31 March 2008.
