WINCHESTER CITY (OFF STREET) PARKING PLACES (VARIATION) ORDER 1996

1. In this Order "the Principal Order" means the Winchester City (Off Street) Parking Places (No.2) Order 1992 as amended.

2. As a consequence of the making of the Road Traffic (Permitted Parking Area and Special Parking Area) (County of Hampshire, City of Winchester) Order 1996 under Schedule 3 of the Road Traffic Act 1991, "the Principal Order" is hereby varied in the following manner:-
 - (i) for the words "Car Park Warden" in every article where they appear there shall be substituted "Parking Attendant"
 - (ii) for the words "excess charge" in Articles 11 and 12 thereof there shall be substituted the words "penalty charge"
 - (iii) for Articles 14 and 15 thereof there shall be substituted the following articles:-

"14. Manner of Payment of Penalty Charge

The driver of a vehicle in respect of which a penalty charge has been incurred shall pay the penalty charge to the Council either by cheque or postal order which shall be delivered or sent by post so as to reach the Finance Department of the Council at City Offices, Colebrook Street, Winchester not later than 10.00 a.m. on the twenty-eighth day following the day on which the charge was incurred or in cash in person at the said department not later than as aforesaid.

Provided that if the said twenty-eighth day falls upon a day upon which the said Department is closed, the period within which the payment of the charge shall be made to the Council shall be extended until 10.00 a.m. on the next full day on which the said department is open.

Reduced Amount of Penalty Charge


In the event of payment being received by the Finance Department as aforesaid within 14 days of the day when the Penalty Charge was incurred (provided that if the fourteenth day falls upon a day on which the Department is closed the period within which payment of the Penalty Charge as provided herein shall be extended until 10.00 am on the next full day on which the said Department is open) the amount of the Penalty Charge shall be reduced to £20 and the said payment of the sum of £20 shall be accepted in full settlement of the Penalty Charge payable under the terms hereof."

- (iv) In Article 11(g) thereof for the words "an additional amount of £30.00" there shall be substituted "an additional amount of £40".
- (v) For the words "initial charge" in Article 8 thereof there shall be substituted the words "parking charge".
- (vi) In Article 3 of "the Principal Order" for the words "'Car Park Warden" means the person authorised by or on behalf of the Council to supervise any parking place and includes any other officer or servant of the Council employed to control and manage any of the parking places provided by the Council;" there shall be substituted

the words " "Parking Attendant" as defined by S.63 of the Road Traffic Regulation Act 1984 as amended by S.44 of the Road Traffic Act 1991."

(vii) Article 25 of "the Principal Order" shall be amended by adding "other than a contravention or non-compliance in relation to a stationery vehicle to which the Road Traffic Act 1991 (Amendment of Schedule 3) (England & Wales) Order 1996 applies.

3. "the Principal Order" is hereby varied by deleting from Schedule I columns 1 - 7 inclusive relating to "Southgate Street".
4. "the Principal Order" is hereby varied by deleting columns 1-7 inclusive from Schedule I thereof relating to "Park Avenue".
5. Except for the variations referred to in Articles 2, 3, and 4 of this Order "the Principal Order" shall remain in full force and effect.
6. This Order may be cited as the Winchester City (Off Street) Parking Places (Variation) Order 1996 and will come into effect on the 20th day of May 1996.
