# THE WOLVERHAMPTON CITY COUNCIL (MOLINEUX STADIUM) (EXPERIMENTAL) TRAFFIC REGULATION ORDER 2017

Wolverhampton City Council ("the Council") in exercise of its powers under Sections 1 (1) and (2), 2(1) to (3), 9,10(1) and (2), of the Road Traffic Regulation Act 1984 ("the Act") as amended ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

Definitions -

"event" means any event held at Molineux Stadium

"kick off" and "final whistle" relate to any football match held at Molineux Stadium

"match" means any football match held at "Molineux Stadium"

#### 1 Citation and Commencement

This Order shall come into operation on 13 Ochber 2017 and may be cited as Wolverhampton City Council (Molineux Stadium) (Experimental) Traffic Regulation Order 2017.

#### 2 Prohibited Times

No person shall cause or permit any vehicle to enter or proceed in any length of road specified in Schedule 1 for a period commencing 1.5 hours prior to the start of the event/kick off until 1.5 hours after the final whistle/end of the event or such other time periods agreed between the Council and Wolverhampton Wanderers Football Club, in their absolute discretion, decide that the restriction should apply

#### 3 **Prohibition of Stopping**

- (i) No person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to stop or remain at rest at any time on a match/event day at Molineux Stadium, that the Council, at their absolute discretion, decide that the restriction should apply in the roads specified in Schedule 2.
- (ii) Nothing in Article (i) shall render it unlawful for a person to cause or permit a vehicle to stop or wait in the lengths of road specified in Schedule 2 if the vehicle is being used for fire, police or ambulance purposes being used in pursuance of statutory powers or duties;
- (iii) Where a police officer in uniform, Wolverhampton Wanderers Football Club or their appointed representative is of the opinion that any of the provisions contained in Article (i) have been contravened or not compiled with in respect of a vehicle they may disable, and/or remove the vehicle and where it is so removed shall provide for the safe custody of the vehicle.
- (iv)Where a vehicle has been removed in accordance with Article 3(iii) the owner/registered keeper of the vehicle may secure the return of the vehicle from Wolverhampton Wanderers Football Club or their appointed representative upon payment of a fee

## 4 Exempted Vehicles

Nothing in Articles 2 and 3 shall apply to any vehicle being used in connection the enforcement of prohibited traffic movements in the vicinity of Molineux Stadium on match/event days and displaying a valid permit issued by Wolverhampton Wanderers Football Club

North Road	From its junction with Molineux Street to a point 30 metres from the northern kerb line of Camp Street in a northern direction	
Nursery Street	For its entire length	
Waterloo Road	From its junction with New Hampton Road East to its junction with Jack Haywood Way	
Whitmore Hill	As per hatched area shown on plan T4/3860A	
Molineux Alley	As per hatched area shown on plan T4/3860A

Camp Street	All	For its entire length
Deanery Row	All	For its entire length
Jack Hayward Way	North east, south west	From a point 85 metres from its junction with Molineux Street to said junction.
Molineux Street	North, east, south, west	From its junction with North Road to the end of Molineux Street
Nursery Street	All	For its entire length
North Road	East, west	From its junction with Molineux Street to a point 103 metres from the northern kerb line of Camp Street in a northern direction
Waterloo Road	East, west	From its junction with New Hampton Road East to its junction with Jack Haywood Way
Whitmore Hill	North, South	For its entire length
Molineux Alley	All	From its junction with Whitmore Hill to a point 23 metres from the southern

kerb line of Whitmore Hill in a southern direction.
