

THE WOLVERHAMPTON CITY COUNCIL (DUNSTALL LANE/CARTER ROAD)

(PROHIBITION OF WAITING) ORDER 2007

Wolverhampton City Council in exercise of the powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order shall come into operation on the *16th March 2007* and may be cited as the Wolverhampton City Council (Dunstall Lane/Carter Road) (Prohibition of Waiting) Order 2007.
2. (1) "disabled person's badge" has the same meaning as in the Disabled Persons (Badge for Motor Vehicles) Regulations 1982 as amended by the "Disabled Person's (Badge for Motor Vehicles)" Regulations 1982 as amended by the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 1991;

"disabled person's vehicle" has the same meaning as the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1986 as amended by the Local Authorities Traffic Orders (Exemption for Disabled Persons) (England and Wales) (Amendment) Regulations 1991;

"parking disc" means a disc, issued by a Local Authority, 125 millimetres square, coloured orange, and capable of showing the quarter hour period during which a period of waiting begins.
 - (2) For the purpose of this Order a vehicle shall be regarded as displaying:-
 - (i) a disabled person's badge issued before 2nd March 1992 in the relevant position if -
 - (a) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon on the near side of and immediately behind the windscreen and with its front facing forward so as to be legible from outside the vehicle; or
 - (b) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the vehicle;
 - (ii) a disabled person's badge issued on or after 2nd March 1992 in the relevant position if -
 - (a) in the case of a vehicle fitted with a dashboard or fascia panel, the badge is exhibited thereon so that Part 1 of the badge is legible from outside the vehicle; or
 - (b) in the case of a vehicle not fitted with a dashboard or fascia panel, the badge is exhibited in a conspicuous position on the vehicle so that Part 1 of the badge is legible from outside the vehicle;
 - (iii) a parking disc in the relevant position if -
 - (a) in the case of a vehicle fitted with a dashboard or fascia panel, the disc is exhibited thereon so that the quarter-hour period during which the period of waiting began is legible from outside the vehicle; or

- (b) in the case of a vehicle not so fitted, the disc is exhibited in a conspicuous position on the vehicle so that the quarter-hour period during which the period of waiting began is legible from outside the vehicle.
- 3. Save as provided in Article 4, no person shall except upon the direction or with the permission of a parking attendant, cause or permit any vehicle to wait in any of the lengths of roads specified in the schedule hereto
- 4. (1) Nothing in Article 3 shall render it unlawful to cause or permit any vehicle to wait on the length of roads referred to therein for so long as may be necessary to enable -
 - (a) a person to board or alight from the vehicle;
 - (b) the vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in connection with any of the following operations, namely-
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said lengths of roads or
 - (iv) the laying, erection or repair in, or on land adjacent to the said lengths of roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus line as defined in the Telecommunications Act 1984;
 - (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or a water authority in pursuance of statutory powers or duties;
 - (d) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953;
 - (e) the vehicle to wait at or near to any premises situated on or adjacent to the said lengths of roads for so long as such waiting by that vehicle is reasonably necessary in connection with any wedding or funeral;
 - (f) the vehicle to be used for fire brigade, ambulance or police purposes;
or
 - (g) goods to be loaded on or unloaded from the vehicle
- (2) Nothing in Article 3 shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the length of road referred to in that Article for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length of road on the same day).

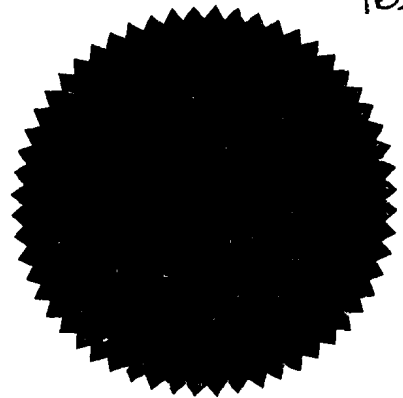
