**THE WYCHAVON DISTRICT COUNCIL (OFF-STREET PARKING PLACES)
(CONSOLIDATION) (VARIATION) (NO. 1) ORDER 2008**

THE WYCHAVON DISTRICT COUNCIL in exercise of its powers under Section 35(1) and (3) of the Road Traffic Regulation Act 1984 (hereinafter referred to as "The Act") and Part IV of Schedule 9 to the Act, and of all other enabling powers, with the consent of Worcestershire County Council in accordance with Section 39(3) of the Act and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby makes the following Order:-

1. This Order shall come into operation on the 1st day of DECEMBER 2008 and may be cited as the Wychavon District Council (Off-Street Parking Places) (Consolidation) (Variation) (No. 1) Order 2008.
2. The Wychavon District Council (Off-Street Parking Places) (Consolidation) (Order) 2004 is hereby varied by:-

The incorporation in Schedule 1 to the Order of the additional short stay car park at Evesham Chapel Street by the insertion in Schedule 1 to the Order after "Evesham Oat Street Car Park (Short Stay)" of the wording set out in Schedule A to this Variation Order.

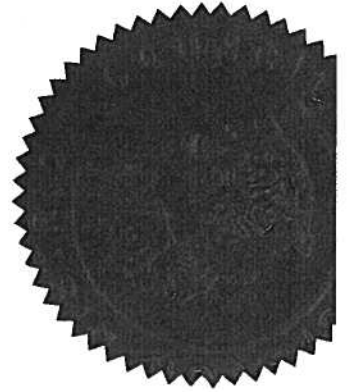

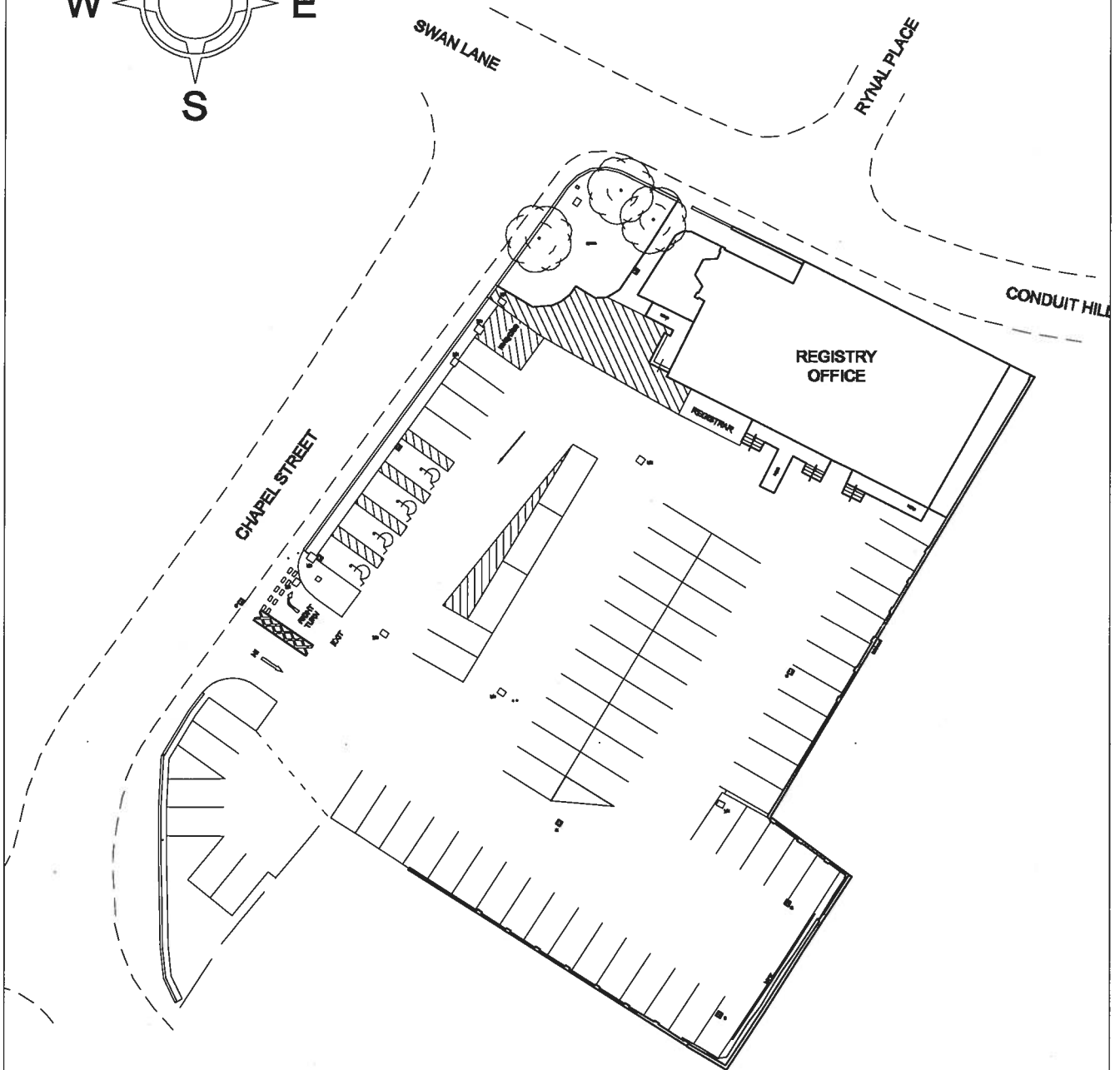
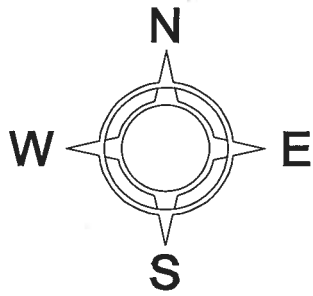
