WYCHAVON DISTRICT COUNCIL in exercise of its powers under Section 35(1) and (3) of the Road Traffic Regulation Act 1984 (as amended) hereinafter referred to as "The Act") Part IV of Schedule 9 to the Act and all associate Regulations and other enabling powers, with the consent of Worcestershire County Council in accordance with Section 39(3) of the Act and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby makes the following Order: -

The existing Schedule 1 to the Order shall be superseded by the new Schedule 1 attached to this Variation Order.


