## THE YORK OFF-STREET PARKING PLACES (AMENDMENT) (NO 11/1) ORDER 2013

City of York Council, in exercise of powers under Sections 33, 35 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Schedule 9 of the Road Traffic Regulation Act, 1984 ("1984 Act") hereby makes the following Order:

- 1. This order may be cited as "The York Off-Street Parking Places (Amendment) (No 11/1) Order 2013" and shall come into effect on the 21<sup>st</sup> day of January 2013.
- 2. The York Off-Street Parking Places Order 2011 (the Order) is amended by:
  - (a) the deletion from Columns 2 to 8 of the First Schedule of the entries against the name of the parking place "St Leonard's Car Park" in Column 1 and the substitution to the respective Columns of the following entries;

- (b) the addition to Column 2 of the First Schedule against each of the headings "Marygate Car Park" and "Nunnery Lane Car Park" in Column 1 of the entries "GCP", "GCP(N)" and "GCP(LE)";
- (c) the deletion from Column 1 of Part 1 of the Third Schedule of the Tariff and Parking Place "SL Car Park at: St. Leonard's" and the deletion from Column 2 and 3 of the entries set against that parking place. The said deletion to take effect at 2400 hours on the 4<sup>th</sup> day of April 2013;
- (d) the addition to Column 1 of Part I of the Third Schedule under Tariff "S" of the Parking Place "St Leonard's" the said addition to take effect at 0001 hours on the 5<sup>th</sup> day of April 2013;
- (e) the deletion of "St Leonard's Car Park" and any reference thereto from the Order the said deletion to take effect at 2400 hours on the 1<sup>st</sup> day of June 2013;
