THE YORK PARKING, STOPPING AND WAITING (AMENDMENT) (No 11/5)
TRAFFIC ORDER 2012

The Council for the City of York, in exercise of powers under Sections 1, 2, 4, 32, 35, 45, 46, 53 and Schedule 9 of the Road Traffic Regulation Act 1984 (the Act) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Schedule 9 of the Act hereby makes the following Order:

1. This Order may be cited as the York Parking, Stopping and Waiting (Amendment)(No 11/5) Traffic Order 2011 and shall come into effect on the 16th day of January 2012.
2. The York Parking, Stopping and Waiting Traffic Order 2011 (the Order) is amended by:
 - (a) the addition to Article 2(2) of the following:

““Zonal Parking Place” means a parking place within a road or area of roads the said Parking Place being any length of road not subject of any prohibition or restriction identifiable by the placement of traffic, stopping, parking or waiting signs in the form of plates and/or road markings that length being identifiable as being within a Zone by the placement of traffic signs at the entry and exit from that Zone”,
 - (b) the insertion of the designation “Zonal Res. P” between the designations “Res.P” and “Comm.P” in line 2 of Article 5 (1) and in line 1 of Article 7(i)(a),
The said road or area of road being a Zone,
 - (c) the deletion of the entries in Columns 1 to 3 of Part II of the First Schedule against the roads – HESLINGTON - “FIELD LANE SERVICE ROAD”, “LOW MILL CLOSE”, “UNIVERSITY ROAD”, HESLINGTON/YORK – “BADGER WOOD WALK” and “DERAMORE DRIVE”, and the substitution to the respective Columns of the entries set out in Part I of the First Schedule to this Order,
 - (d) the addition to the respective Columns of Part I of the First Schedule of the entries set out in Part II of the First Schedule to this Order,
 - (e) the addition to the respective Columns of Part I of the Fifth Schedule of the entries contained in the Second Schedule to this Order,
 - (f) the addition to Part II of the Fifth Schedule of the Plan entitled “R59 YORK/HESLINGTON(BADGER HILL)” contained in the Third Schedule to this Order.
