THE YORK TRAFFIC MANAGEMENT (AMENDMENT) (no 11/7)
TRAFFIC ORDER 2014

City of York Council, (the Council), in exercise of powers under Sections 1, 2, 3, 4 and Schedule 9 of the Road Traffic Regulation Act 1984 (the Act) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Schedule 9 of the Act and being satisfied that for avoiding danger or the likelihood of danger arising to persons or other traffic using the roads to which this Order relates where access for a class of vehicle is prohibited for more than eight hours in twenty four it is requisite that Section 3(1)(b) of the Act should not apply to the Order, hereby makes the following Order:

PART I - GENERAL

CITATION

1. This Order may be cited as The York Traffic Management (Amendment) (No 11/7) Order 2014 and shall come into effect on the 12th day of May 2014.
2. The York Traffic Management Order 2011 (or any replacement thereof) is amended by:
 - (a) the addition to Article 2 (2) of the following:

“Dial a Ride Service” means a service being operated by or on behalf of City of York Council to convey residents having mobility difficulties between their respective homes and York City Centre, major supermarkets and local shops by means of buses specially equipped to meet the needs in terms of seating/walking aids/wheelchairs for those being conveyed;
 - (b) the deletion of sub-paragraph 2(a) and 5 from Article 3 and the substitution of the entry set out in Part I of the First Schedule to this Order;
 - (c) the addition to the respective Columns of Part I of the First Schedule of the entries set out in Columns 1 and 2 of Part II of the First Schedule to this Order;
 - (d) the addition of “Exemption No. 121” to Column 4 of Part II of the First Schedule against the entry “Pedestrian Period” in Columns 2 and 3 against the roads: “CHURCH STREET”, “COLLIERGATE”, “DAVYGATE”, “KING’S SQUARE” and “ST SAMPSON’S SQUARE”;
 - (e) the deletion of the time periods “10.30–4pm” and “Mn–10.30am and 4pm–Mn” from Column 3 of Part II of the First Schedule against the road “GREAT SHAMBLES” in Column 1 and the substitution of the respective time periods “10.30am–5pm” and “Mn–10.30 and 5pm–Mn”;
 - (f) the deletion of the entries in Columns 2 and 3 of Part III of the First Schedule against the road “YORK” – “ST SAMPSON’S SQUARE – north east side, north west side and south west side” in column 1 and the substitution to the respective Columns of the entries contained in the Second Schedule to this Order;
 - (g) the deletion of the road “DAVYGATE” from Column 3 of the Second Schedule against the heading “DISABILITY PERMIT” in Column 1;
3. The York Parking, Stopping and Waiting Traffic Order 2014 (or any replacement thereof) is amended by the deletion of the designation “NL 10/4” from Column 3 of Part II of the First Schedule against the roads “PATRICK POOL”, “NEWGATE” and “SILVER STREET” in Column 1;

FIRST SCHEDULE

(DRIVING RESTRICTIONS)

- (2) (a) Where the following designations appear in Columns 2 and 3 they shall mean that the following entries are made under those Columns:
